Vide No. FIN/Rop/Rel-8/87/Vol-II dated 26/10/10 standing order of release of Dearness Relief to the Nagaland, State Government Pensioners/ Family Pensioners as and when sanctioned by the Government of India without any further order from the State Government or authorization from the Accountant General has been kept in abeyance till further notice (vide Finance Department, Government of Nagaland No.FIN/ROP/REL-8/87/(Voi.II) dated 26th February 2016). In future for Revision of Dearness Relief, separate authorisation will be issued as and when the same is revised by the State Government of Nagaland.



OFFICE MEMORANDUM

Subject: Payment of Dearness Relief to Nagaland Government Pensioners/Family Pensioners.

The undersigned is directed to refer to this department's notification of even number dated 22nd May, 2017 and to state that the Governor of Nagaland is pleased to sanction Dearness Relief to Pensioners of the Government of Nagaland and Family Pensioners from the existing rate of 136% to 139% with effect from 01.07.2017.

- 2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 3. Other provisions governing Dearness Relief to the Pensioners such as regulation of Dearness Relief on re-employment, regulation of Dearness Relief where more than one pension is drawn, etc. shall remain unchanged.
- Authorized Public Sector Banks, Treasuries/Sub-Treasuries are requested to arrange for payment of Dearness Relief to the pensioners on the basis of the above instruction.
- The Accountant General, Nagaland, is requested to circulate this O.M. to the Accountants General of all States so that Pensioners of the Government of Nagaland drawing pensions under their jurisdiction may be authorized for payment of this relief at the earliest.




