This is for the information of all Departments and Treasury officers that copies of respective offices may be collected from this office w.e.f 24.07.2025. This is to also inform all Departments once again that since this office relies on PIMS data for confirmation of pension cases, a preliminary check on all pension cases will be initiated at the Reception Cell before officially receiving the Pension cases for settlement. The basic information to be checked are as follows:

1. Name should match in both PIMS and service book
2. Date of birth should match in both PIMS and service book
3. Date of entry into Government service should match in both PIMS and service book
4. Date of retirement should match in both PIMS and service book
5. The ID mark of a government servant should match in descriptive roll and service book .
6. Name and date of birth as recorded in the Aadhaar card may be furnished in both service book and list of family membrs.
7. The Head of the Department will be the pension sanctioning authority in case of Non-gazetted officials and the Secretary of the concerned department will be the pension sanctioning authority for gazetted officers.
8. Photocopy of service book for process of pension will not be accepted. All Departments are requested to submit original service book for process of pension.
9. AIS Officers (IAS, IPS & IFS) may submit a self-signed undertaking whether to avail CGHS or AMA. The preliminary check on Pension papers is being done to avoid sending of objections/observations at a later stage. Therefore, all stakeholders are kindly requested to kindly cooperate for betterment of the system.
