Subject: Clarification on admissibility on Dearness Relief in respect of those pensioners/family pensioners whose pension/family pension at revised rate has commenced within 01.01.2020 and 31.12.2020 since "No Dearness Relief at present" is shown in the PPOs.

This office is in receipt of certain communications from some banks, authorised to make payment of pensionary benefits to the West Bengal Govt. pensioners with the request to clarify whether the pensioners retired/died-in-harness between the period from 01/01/2020 to 30/12/2020 and authorities/revised authorities for the benefits have been issued by this office at revised rate as per ROPA, 2019 are eligible for dearness relief at present since in the PPO/FPPO issued for such cases it has been mentioned that "No Dearness Relief at Present".

It is stated in this context that Govt. of west Bengal vide their memorandum under No. 535-F (Pen) and 536-F (Pen) both dated 1/10/2019 have issued orders regarding date of effect of ROPA, 2019 w.e.f. 01.01.2020 for both pre and post 2016 pensioners/family pensioners when there was no dearness relief on their revised pension as per ROPA, 2019 within 01.01.2020 and 31.12.2020 which was circulated to all banks vide No. Pen. Co-ordn/345/162 dated 20/01/2020 and Pen. Co-ordn/345/195 dated 12/3/2020. Hence, "No Dearness Relief at present" is shown in the PPOs issued for the pensioners/family pensioners whose date of effect of commencement of revised pension/family pension was between 01.01.2020 to 31.12.2020.

However, this office has subsequently circulated orders of commencement/enhancement of Dearness Relief at revised rate to all banks concerned as and when orders for Dearness Relief are issued by Finance Department, Govt. of West Bengal to all Pension Disbursing Authorities from time to time w.e.f. 01/01/2020.

As such, it is clarified that the phrase "No Dearness Relief at present" in the Pension Payment orders (Part I) issued for pensioners and family pensioners whose revised pension/family pension commenced between 01.01.2020 to 31.12.2020 is applicable for that year i.e. for 2020 only and thereafter he/she is entitled to Dearness Relief, if it is otherwise admissible as per extant rule, at the rates and from the dates as allowed by Govt. of West Bengal for their pensioners/family pensioners from time to time and circulated by this office.

Accordingly, based on the instructions issued from this office regarding enhancement of Dearness Relief after issuance of orders from Govt. or West Bengal, all Pension Disbursing Authorities are requested to act accordingly without further correspondences in this respect.

The Government of India have enhanced the existing rate of Dearness Relief on Pension / Family Pension from 55% to 58% of the Basic Pension/ Family Pension (including additional pension/family pension) with effect from 01/07/2025 in O.M.No.42/02/2024-P&PW(D), dated 08/10/2025 of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare, New Delhi.

- 2. The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of **Dearness Relief** @ 58% with effect from 01/07/2025 to the Pensioners / Family Pensioners of the Union Territory of Puducherry vide G.O. Ms. No.44/FD/F3/A2/2025-26, dated 22/10/2025 of the Finance Department, Puducherry.
- 3. On the basis of the above orders, I am to authorize to effect payment of Dearness Relief at the revised rate of 58% as mentioned above with effect from 01/07/2025 to all eligible Pensioners / Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks / Treasuries / Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension / Family Pension as detailed in the Government of India Office Memorandum aforesaid.

OFFICE MEMORANDUM

Subject: - Release of an additional installment of Dearness Relief (DR) to Central Govt. Pensioners/Family Pensioners revised rate with effective from 01.07.2025-reg.

The undersigned is directed to refer to this Department's OM No. 42/02/2024-P&PW(D) dated 11.04.2025 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 55% to 58% of the basic pension/family pension (including additional pension/family pension) w.e.f 01st July, 2025.

- 2. These rates of DR will be applicable to the following categories:-
- (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
- (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
- (iii) All India Service Pensioners/Family Pensioners.
- (iv) Railway Pensioners/Family Pensioners.
- (v) Pensioners who are in receipt of provisional pension
- (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

- 4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528- TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 8. In so far as the persons serving in Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.
- 9. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/4(i)/2025-E.II(B) dated 06.10.2025.

- 1. In continuation of this department's O.M. No. Fin (Pen)B(10)-6/98-IV-Loose dated 19th October, 2024, the undersigned is directed to say that the Governor, Himachal Pradesh is pleased to decide that dearness relief @ 3% will be paid to the Government pensioners/family pensioners including AIS pensioners/family pensioners w.e.f. 01.07.2023. Accordingly, existing rate of dearness relief will enhance from 42% to 45% after this decision.
- 2. The additional Dearness Relief shall be paid with the pension/family pension for the month of October, 2025, payable in the month of November, 2025. The arrears of dearness relief @ 3% w.e.f. 01.04.2025 to 30.09.2025 shall be credited in Bank Account of the pensioners in the month of October, 2025. The decision on payment of arrears of dearness relief for the period 01.07.2023 to 31.03.2025 will be taken separately in due course of time.
- 3. Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of dearness relief to pensioners, such as, regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
- 5. As dearness relief will be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority

ORDER

Government are pleased to order that the rates of Dearness Allowance payable in respect of the teaching staff coming under UGC/AICTE/Medical Education Schemes who have changed over to revised UGC/AICTE/Medical Education scale from 01.01.2016 or thereafter will be enhanced from the existing 42% to 46%.

2. The rates of Dearness Allowance payable in respect of the teaching

staff coming under UGC/AICTE/Medical Education Schemes who are continuing in the 6th UGC/AICTE/Medical Education scale from 01.01.2006 or thereafter will be enhanced from the existing 221% to 230%.

- 3. The rates of Dearness Relief payable to UGC Pensioners/Family pensioners whose Pension/Family pension has been revised as per Government Order read 1st above will be enhanced from the existing 42% to 46%.
- 4. The rates of Dearness Relief payable to UGC Pensioners/Family pensioners whose Pension/Family pension had not been revised as per Government Order read 1st above will be enhanced from the existing 221% to 230%.
- 5. The enhanced Dearness Allowance shall be started to draw along with the salary due from the month of October 2025. i.e., salary to be disbursed from November 2025.
- 6. The enhanced Dearness Relief shall be started to draw along with the pension due for the month of November 2025, i.e, pension to be disbursed from November 2025.
- 7. The enhanced rate of dearness allowance is applicable, subject to availability of funds, to grant-in-aid institutions, including RCC, MCC etc. where UGC/AICTE/Medical Education Scheme has been implemented through Government Order. The increased rate of dearness relief is applicable only to institutions, including universities, where statutory pension is followed by Government order. The

enhanced rate of Dearness Allowance and Dearness Relief should not 46% exceed (230% for those continuing in the 6th UGC/AICTE/Medical Education scale effective from 01.01.2006 or thereafter). Such institutions can sanction the enhanced rate of Dearness Allowance and Dearness Relief after obtaining approval of the Board Directors/Governing Body/Managing Committee/Executive Committee etc.

ORDER

The rates of Dearness Allowance payable to State Government Employees, Teachers, Staff of Aided Schools, Private Colleges and Polytechnics, full time contingent employees and employees of Local Governments and the Dearness Relief payable to State Service Pensioners, Family Pensioners, Ex-gratia Pensioners and Ex-gratia Family Pensioners will be enhanced from the existing 18% to 22%.

2. The Dearness Allowance payable in respect of those employees continuing in the pre-revised scale will be enhanced as shown below:

3. The Dearness Relief payable in respect of those pensioners who are drawing pension in the pre-revised scale will be enhanced as shown below:

- 4. The additional expenditure on this account in respect of Local Governments will be met by them from their own funds.
- 5. The enhanced rate of Dearness Allowance will also be made applicable to part time teachers and part time contingent employees on the basis of pay drawn by them and to re-employed pensioners.
- 6. The employees / pensioners of State Public Sector Undertakings /Statutory Corporations / Autonomous Bodies / Boards / Grant-in-aid institutions on State Dearness Allowance/Dearness Relief pattern are eligible for this enhanced rate of Dearness Allowance/Dearness Relief, subject to the following conditions:
 - i. Those organisations which are already on the State pattern of Dearness Allowance/Dearness Relief can release the enhanced rates of Dearness Allowance/Dearness Relief to their employees/pensioners without referening to Government, but based on a decision by the Board of Directors/Governing Body/Managing Committee/ Executive Committee taking into account the ability of the organisation to meet the expense from its own resource.
 - ii. If the organisation cannot meet such expenses on its own, prior

approval of the Government must be taken. Those organisations where more than 90% of the salary/pension expenses are met by Plan/Non Plan grant from the Government, can release Dearness Allowance/Dearness Relief without prior approval of the Government but with the approval of the Board of Directors/ Governing Body/Managing Committee/Executive Committee etc.

- iii. This Dearness Allowance/Dearness Relief enhancement is not applicable to those organisations which have been instructed to issue separate Dearness Allowance/Dearness Relief orders (eg. KSEB, KSRTC etc). Such organisations should follow the current practice including prior approval of Government, if any, while sanctioning Dearness Allowance/Dearness Relief to their employees/pensioners.
- 7. Dearness Allowance at the enhanced rate shall be disbursed along with the salary due for the month of October 2025. i.e, salary disbursed in November 2025.
- 8. Dearness Relief at the enhanced rate shall be disbursed along with the pension due for the month of November 2025. i.e, pension disbursed in n November 2025.
