- 3. Their pay in Level-10 of 7th CPC Pay Matrix will be fixed under Rule 13 of CCS (Revised Pay) Rules 2016, notified vide Gazette Notification G.S.R. 721(E).F.No. 1-2/2016-IC dated 25.07.2016. They may exercise the option for fixation of pay on promotion within one month from the date of promotion. The promoted officers, who have got financial upgradation under the scheme of MACP in Level-10, will not be entitled for pay fixation benefit on promotion.
- 4. This promotion shall be subject to the judgement dated 28.01.2022 of the Hon'ble Supreme Court of India in Jarnail Singh and Ors. in Civil Appeal No. 629/2022 arising out of SLP (C) No. 30621/2011, and further orders that may be passed by Hon'ble Supreme Court in the said batch of cases, pending in the Supreme Court of India, as mentioned in DoPTS OM No. 36012/16/2019-Estt. (res.) dated 12.04.2022. Further, in terms of para-05 of DoPT's O.M. No. 36012/11/2016-Estt (Res.1) (Pt.-11) dated 15.06.2018, the promotion shall be subjected to further orders which may be passed by the Hon'ble Supreme Court.

As per Recruitment Rules for the post of Senior Divisional Accounts Officer, notified in Part-II Section 3, Sub-section (i) of Gazette of India vide GSR No. 10 dated 17.01.2020 published in Gazette of India on 25.01.2020, on their promotion, Senior Divisional Accounts Officer will be on probation for a period of 2 (two) years followed by confirmation.
