
Sub: Grant of Dearness Relief to Pensioners and Family Pensioners of Union Territory of Puducherry - Revised rates effective from 01/07/2021 - Reg.

The Government of India have enhanced the existing rate of Dearness Relief on Pension / Family Pension from **17% to 28%** of the Basic Pension/ Family Pension (including additional pension/family pension) **with effect from 01/07/2021** in **O.M.No.42/07/2021-P&PW(D), dated 22/07/2021** of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare, New Delhi.

2. The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of **Dearness Relief @ 28% with effect from 01/07/2021** to the Pensioners / Family Pensioners of the Union Territory of Puducherry **vide G.O. Ms. No.26/ FD/F3/A2/2021-22, dated 27/07/2021** of the Finance Department, Puducherry.

3. On the basis of the above orders, I am to authorize to effect payment of Dearness Relief at the revised rate of **28%** as mentioned above with effect from **01/07/2021** to all eligible Pensioners / Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks / Treasuries / Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension / Family Pension as detailed in the Government of India Office Memorandum aforesaid.
