The Governor is pleased to order that the existing rate of Dearness Relief sanctioned vide Finance Department Order of even number dated 25-04-2022 to the State Government Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extraordinary pension etc. shall be revised from 203% to 212% with effect from 01-07-2022.

For the purpose of this order -

- (i) Pension/Family Pension in the case of pre-01-01-2006 retirees and where Family Pension was sanctioned prior to 01-01-2006, means the Consolidated Pension or Consolidated Family Pension, as the case may be, effective from 01-01-2006 in terms of Finance Department Memorandum No. F.12(3)FD(Rules)/ 2008 dated 12-09-2008 as amended vide FD Memorandum dated 06-04-2013.
