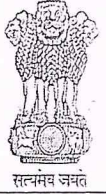

RECOMMENDATION OF DEPARTMENTAL SCREENING COMMITTEE FOR
COMAPSSIONATE APPOINTMENT FOR 2022

1. A Departmental Screening Committee was constituted for the purpose of considering appointment of applicants of officials of the Office of the Accountant General (A&E), Tripura, Agartala who died in harness.
2. The committee was constituted with the following members as per Headquarters' letter No. 97-Staff(A&E)(Rule)CA/02-2022 dated 17/10/2022 & AG's order dated 18/10/2022:

The Committee met on 10/11/2022.

3. In terms of Headquarters' Circular No. 14 (No. 52-Staff Entt. (Rules)/ AR/02-2021) dated 20-04-2022 the committee has considered the applications of compassionate appointment received upto 31-07-2022.

6. The Committee has taken into consideration the following documents before considering the applications for compassionate appointment and arriving at a conclusion.
- GoI OM vide F. No. 14014/1/2022-Estt. (D) dated 02-08-2022.
 - Headquarters Circular No. 14 (No. 52-Staff Entt (Rules/AR/02-2021) dated 20-04-2022.
 - Headquarters letter No. 130-Staff Entt (Rules)/AR/02-2021 dated 24-08-2022.
 - Financial enquiry / Verification report of the applicants.
7. The Committee has carefully considered the applications for compassionate appointment, and other associated records and unanimously recommends the following:

“That the object of the scheme is to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness thereby leaving his family in penury and without any means of livelihood, to relieve family of the government servant concerned from financial destitution and help it to get over the emergency. The details of the deceased government servant in respect of three applicants are as under:

The committee perused the submission of the applicants and the findings of the Inquiry report carefully and the score sheets was filled using the same information.

(i) Family member of **Shri Swadesh Dhanuk**, S/o Lt. Lala Dhanuk, who was employed as MTS got total terminal benefit of Rs. 20,15,055/- . There is no service holder in the family of six members. Family Pension and terminal benefits was distributed between the 1st wife Smti Kamala Dhanuk and elder son from 2nd wife Shri Loknath Dhanuk on the basis of affidavit made in the court by all the family members of Late Lala Dhanuk. Monthly Normal family pension is 11,580/- p.m which was divided @ Rs. 5790/- each. They have no immovable property. In terms of evaluation system Shri Swadesh Dhanuk, S/o Lt. Lala Dhanuk, Ex-MTS got 110, Annexure V(ii)





(ii) Family member of **Shri Sayandeep Debnath**, S/o Lt. Samir Chandra Debnath, who was employed as Assistant Supervisor, got total terminal benefit of Rs. 28,51,419/- , Monthly Normal family pension is Rs19,800/- p.m . There is no service holder in the family of three members . The family possess immovable property which is estimated of Rs. 25,48,750/- (Land , present value Rs.15,03,750.00, building worth Rs. 10,45,000/- (constructed on bank loan). As on date the outstanding bank loan is Rs. 8,52,000/- In terms of evaluation system Shri Sayandeep Debnath, S/o Lt. Samir Chandra Debnath, Ex-A/S got 70 ,Annexure V(ii)

(iii) Family member of **Shri Keshab Debbarma**, S/o Late Nagendra Debbarma, who was employed as MTS, got total terminal benefit of Rs. 19,45,132/- , Monthly normal Family Pension is @ Rs 10,830/- There is no service holder in the family three members . They have no immovable property. The family intimated that Bank loan outstanding is Rs. 582484/- . In terms of evaluation system Shri Keshab Debbarma, S/o Lt. Nagendra Debbarma, Ex-MTS got 95 , Annexure V(ii)

Now, therefore the committee after careful perusal of the facts in submission of applicants the verification and inquiry report the marks obtained by the applicants as per evaluation sheets ; uninomusly, recommends that Sl. No. (i) above **Shri Swadesh Dhanuk**, S/o Lt. Lala Dhanuk, and Sl No. (iii) above, **Shri Keshab Debbarma**, S/o Lt. Nagendra Debbarma, has been found to be suitable for appointment on compassionate ground therefore is found "fit" .
