In inviting a reference to this Office letter No. TMC/3-3/VERFN/2021-22/695 dated 17/01/2022 on the subject cited above, I am to state that, **out of 58** Chief Controlling Officers (CCOs) **12** (Twelve) CCOs have carried out reconciliation of expenditure **fully**, **20** (Twenty) CCOs have carried out reconciliation of expenditure **partially**, **26** (Twenty six) CCOs have **not** at all reconciled the departmental expenditure figures and on the **Receipt** side, **4** (Four) CCOs have reconciled the receipt figures **fully** and **5** (Five) CCOs have carried out reconciliation of receipt **partially**, **49** (Forty nine) CCOs have **not** at all reconciled for the quarter ended 30<sup>th</sup> June, 2021.
