In inviting a reference to this Office letter No. TMC/3-3/VERFN/2021-22/111 dated 30/05/2022 on the subject cited above, I am to state that, **out of 58** Chief Controlling Officers (CCOs) **35** (Thirty five) CCOs have carried out reconciliation of expenditure fully, **21** (Twenty one) CCOs have carried out reconciliation of expenditure partially, 2 (Two) CCOs have not at all reconciled the departmental expenditure figures and on the Receipt side, 13 (Thirteen) CCOs have reconciled the receipt figures fully and 3 (Three) CCOs have carried out reconciliation of receipt partially, **42** (Forty two) CCOs have not at all reconciled for the quarter ended 31st March, 2022. A detailed list showing the position of reconciliation is enclosed herewith, in **ANNEXURE-I**, for ready reference.

2. From the position explained above, it may be seen that most of the CCOs have not taken up the issue of reconciliation in full earnest. The Government is, therefore, requested to issue necessary instructions/orders to all the Chief Controlling Officers to carry out the reconciliation work for the next quarter ended June, 2022 (FY 2022-23), to ensure cent percent reconciliation and correctness of the accounts prepared by this office.
