

Please refer to this office letter no PAO-NPS/Option/2022-23/124-132 dated 24.06.2022 and most recent letter no पी.ए.ओ.-एन.पी.एस./Option/2023-24/58 dated 23.05.2023 with attached annexures A and B (Procedure for Option Forms) vide which it was informed that, the Protean CRA has enabled the online functionality to capture the option exercised by Subscriber under Form 1 & 2 in PAO/DDO office login. Accordingly, your office was requested to send after completing the process (as explained in Annexure B) the concerned documents to this PAO.

It is seen that maximum no. of option forms have been received from your office. However, it may be rechecked. If the option form of any NPS subscriber is still pending, the same may also please be sent to this PAO without any further delay. **In case there is no pending option in r/o of any existing NPS subscribers, a NIL report may be sent.**
