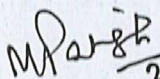

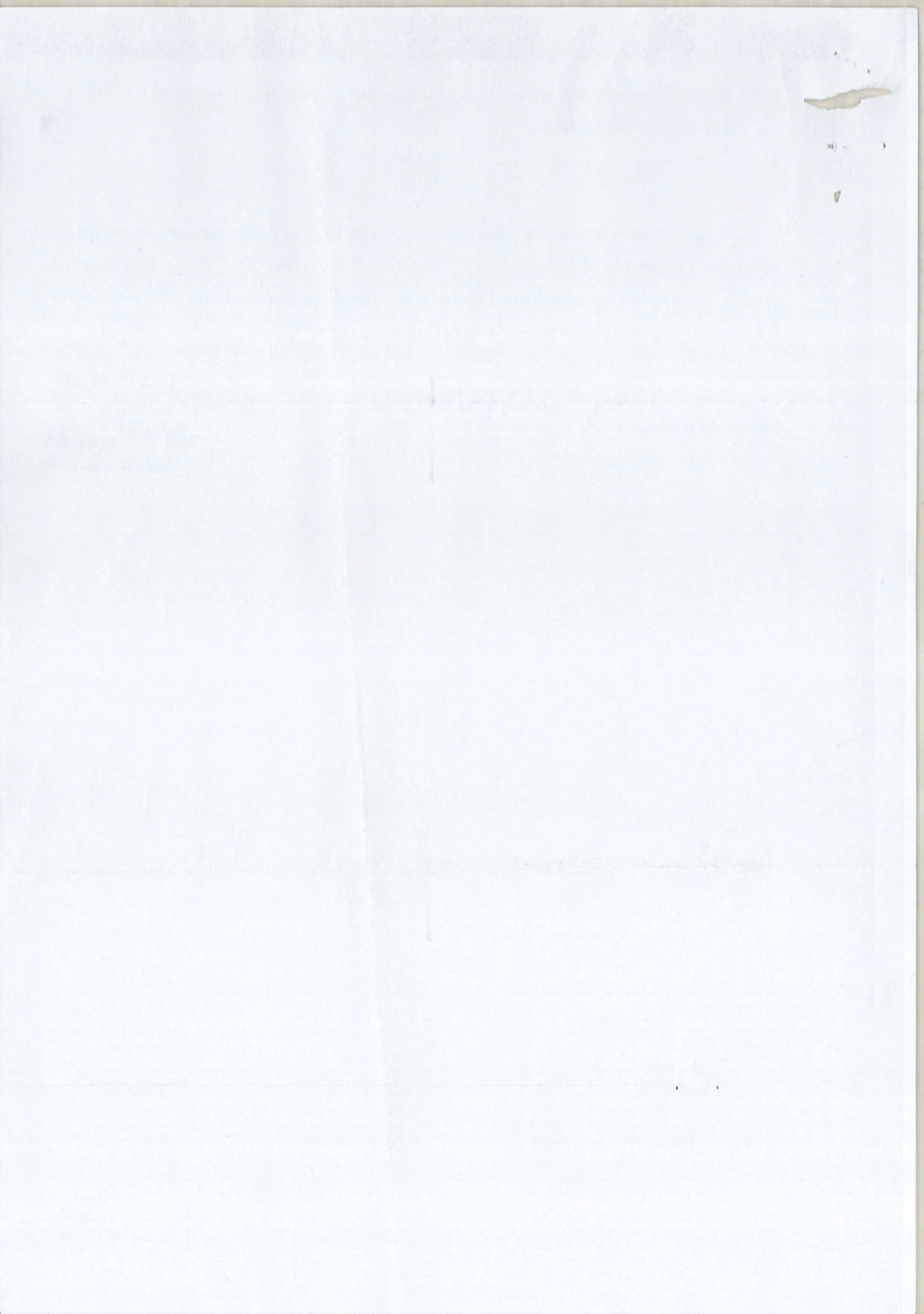

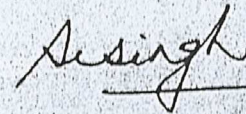
Government in Skill Development and Technical Education Department have issued Notification No. 4007, dated 27.08.2018 under the nomenclature "the Odisha Technical Universities (non-teaching employees) Revised Scales of Pay Rules, 2018" for implementation in BPUT and its constituent Colleges and VSSUT, Burla consequent upon implementation of the revised scales of Pay Rules for the whole time Non-Teaching employees of Technical Universities. Resolution No. 5977/SDTE, dated 31.12.2018 has also been issued for revision of scale of pay in respect of non-teaching employees of IGIT, Sarang. Government in Skill Development and Technical Education Department have also decided to revise the pension/ family pension and other terminal benefits to the Non-teaching employees of BPUT and its constituent colleges, VSSUT, Burla and IGIT, Sarang.

The Skill Development and Technical Education Department have been pleased to approve that the Finance Department Resolution No. 26342/F, dated 07.09.2017, Office Memorandum No. 28300/F, dated 23.09.2017, Circular No. 28046/F, dated 22.09.2017 and other instructions issued by the said Department from time to time applicable to the State Government employees in respect of pension and family pension shall be followed in determining pension/ family pension and other terminal benefits in the BPUT and its constituent Colleges, VSSUT, Burla and IGIT, Sarang under the Skill Development and Technical Education Department regulated by their respective Universities Act and Statutes/ Service Conditions.

The Notification is only applicable to the regular employees covered under the GPF-cum-Gratuity-cum-Pension Scheme of the University/ Institute.

This Notification is issued with the concurrence of Finance Department vide this Department OSWAS file No. SDTE-HTE-HTE-II-0012-2019.
