

Copy of Government Order referred above revising the rate of Family Pension and Medical Allowance admissible to Ex-personal staff of Ministers, Leader of Opposition, Government Chief Whip etc., is endorsed herewith for arranging payment.

Family pension:

The rate of family pension shall be Rs.1200 per month with effect from 1.12.2010 or from the date from which family pension has been authorised whichever is later. All Pension Disbursing Authorities are directed to disburse the enhanced rate of family pension without waiting for revised authorisation from this office or request/application from the beneficiaries.

Medical Allowance:

The rate of Medical Allowance of Ex-personal Staff pensioners/family pensioners stands enhanced to Rs.300 with effect from 01.02.2011

ORDER

In the Government Order 2nd read above, Government have sanctioned revision of scales of pay in respect of personal staff of Chief Minister, Ministers, Leader of Opposition etc. Revision of pension and family pension and other related benefits of State Government Pensioners were ordered vide Government Order 1st read above. Consequent on the above orders Government have enhanced the minimum pension of the pensioners belong to the above category to Rs.1200/vide order 3rd read above. Government vide order read 4th above have sanctioned commutation, family pension and medical allowance to those who have retired from the personal staff of the Ministers, Leader of Opposition and Government Chief Whip etc. In the Government Order 5th above, the revision of scales of pay in respect of personal staff of Chief Minister, Ministers, Leader of Opposition etc. has been given with effect from 01.07.2009.

- 2) Government after having examined the matter in detail are pleased to modify the pension revision order in respect of the persons directly recruited to the personal staff of the Ministers Leader of Opposition and Government Chief Whip etc., read 3rd above under following conditions:
 - I) The Minimum family pension shall be revised as Rs.1200/- per month from Rs.600/- per month.
 - ii) The rate of Medical Allowance shall be revised as Rs.300/- per month from Rs.100/- per month w.e.f 01.02.2011.
 - iii) The date of effect of Order read 3rd above shall have effect from 01/07/2009 in accordance with the Government order read 5th above.
