

Sub: Revision of pension of persons directly recruited to the personal staff of Ministers, Leader of Opposition and Government Chief Whip-reg

2. GO(P) 116//2016/Fin dated 15.08.2016 (copy enclosed)

As per the GO read as first paper above, Government of Kerala have issued orders revising the pension and related benefits of Kerala State service pensioners/family pensioners with effect from 1.7.2014. These orders were not applicable to the Expersonal staff of Ministers etc. As per reference read as 2nd paper above, Government have issued orders revising pension of Ex-personal staff of Ministers, Leader of Opposition and Government Chief Whip. All Treasury Officers/Pension Disbursing Authorities are here by authorised to revise the pension payable to the Ex-personal staff of Ministers, Leader of Opposition and Government Chief Whip, in respect of whom the service as Personal Staff ended before 1.7.2014 in the manner indicated below:

To the existing pension as on 1.7.2014 add

- 1. Dearness Relief at 80%
- 2. Fitment Benefit 18%

The resultant total will be the pension payable from 1.7.2014. The rate of minimum pension has been enhanced to Rs.2400 per month with effect from 1.7.2014. Hence, the total so arrived shall be stepped up to Rs.2400 if it is less than the minimum pension admissible. Maximum pension admissible is Rs.60000.

Family pension:

The rate of family pension has been enhanced from Rs.1200 per month to Rs.2400 per month with effect from 01.07.2014.

Medical Allowance:

Medical Allowance shall be paid at the existing rate of Rs.300 per month.

Dearness Relief:

Dearness Relief on pension and family pension shall be paid at the rate admissible to State Service pensioners.

Date	Rate of DR

01.01.2015	3%
01.07.2015	6%
01.01.2016	9%

Mode of payment of arrears:

The arrears in respect of pension/family pension shall be paid as lump sum.

Revised authorisation will be issued by the Principal Accountant General to those in respect of whom the service as Personal Staff ended on or after 1.7.2014, in due course.

ORDER

Consequent to the revision of pension/family pension and other related benefits of State Government pensioners and family pensioners as per Government Order read above, Government are pleased to revise the rate of pension/family pension in respect of persons directly recruited to the personal staff of Chief Minister, Ministers, Leader of Opposition and Government Chief Whip as follows:

- i) The minimum rate of pension is enhanced to Rs.2400/- per month and is applicable to all who are now in receipt of minimum pension.
- ii) In the case of those who retire on or after 01-07-2014, the pension shall be worked out on the basis of average emoluments on the revised scale of pay with full pension of 50% of average emoluments for 30 years of service and proportionate reduction for service less than 30 years.
- Iii) In the case of those who were in receipt of pension prior to 01.07.2014 their pension shall be revised by merging 80% DR and 18% fitment benefit on the existing pre-revised basic pension.
- iv) The Family Pension of the Personal Staff of Chief Ministers, Ministers, Leader of Opposition and Government Chief Whip is enhanced to Rs.2400/- per month.

- v) The existing rate of medical allowance applicable to the pensioners/family pensioners ie, Rs.300/- per month, shall be continued.
 - vi) The arrears in respect of pension/family pension shall be paid as lump sum.
- vii) The maximum pension will be Rs.60,000/- (ie. maximum pension of state pensioners)
 - viii) The date of effect of this order shall be from 01/07/2014.
