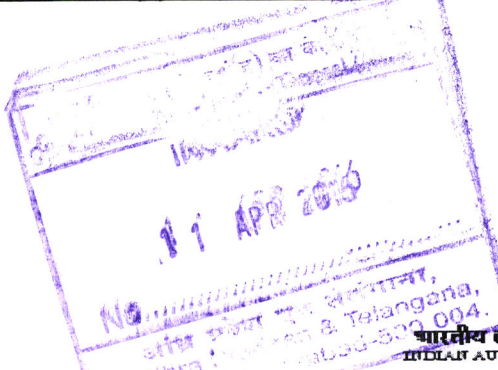





Following amendments are being introduced into the Govt. Resolution No. HCT-2009/Case No. 141/Desk-three dated 5 January 2011 of Law and Judiciary Department :-

**1) Provision No. 1 on Page No. 2 in aforementioned Govt. Resolution :-**

Instead of

“Minimum service period of 20 years is required so that judicial officers in subordinate courts can obtain full pension benefit”

following should be read -

“Minimum qualifying service period of 20 years is required so that judicial officers in subordinate courts retiring on 1.1.2006 or after this date can obtain full pension benefit. Moreover, Minimum 10 years of qualifying service of judicial officer is required to obtain minimum pension.”

**2) Provision No. 6 on Page No. 3 in aforementioned Govt. Resolution :-**

Instead of “2.9.2008 “1.1.2006” should be read.

**3) Provision No. 8 on Page No. 3 in aforementioned Govt. Resolution :-**

Instead of

“Pensioners/family pension receivers in the age group above 65 years will be granted benefit of additional quantum of pension as per following table”

- (1) **Pension:-** The revised pension admissible to judicial officers in subordinate courts retired before 01.01.2006 will be the amount of pension payable for the post held by them at the time of retirement and minimum 50 % of basic pay revised from time to time.
- (2) There will be no limit for maximum pension.
- (3) Neutralization of the cost of living in the same scale as is being extended to the serving judicial officers is payable to judicial officers in subordinate courts retired before 01.01.2006.
- (4) Following incidental allowances are admissible to the judicial officers in subordinate courts retired before 01.01.2006 and to the receivers of family pension.

- (5) The revised pension and incidental allowances to the judicial officers in subordinate courts retired before 01.01.2006 will be introduced from 01.01.2006.
- (6) The pension and family pension rules will be applicable to judicial officers in subordinate courts retired before 01.01.2006 and receivers of family pension.
- (7) The benefit of additional quantum of pension as mentioned in Sr. No. 3 of Page No. 1 will be admissible to the cadre of judicial officers in subordinate courts retired before 01.01.2006 and receivers of family pension.
