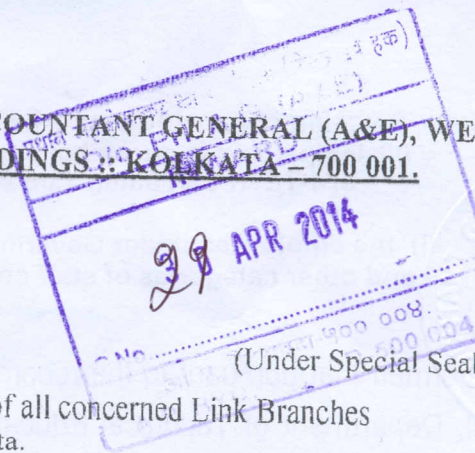

Sub:- Revision of pension of pre-1.1.2006 pensioner/family pensioner of
i) Principal and Lecturer holding pay structure of A.I.C.T.E as per G.O. no.
574-TET(Poly) dated 13/9/2010 under Government Polytechnic.

ii) the employees under Government Polytechnic(except Principi,Lecturer
and other categories of staff covered by recommendation of the A.I.C.T.E.)

It is informed that pursuant to the recommendation of 5th Pay Commission, Govt. of West Bengal, Department of Technical Education & Training, Polytechnic Branch in their Memo. No. 995-TET(Poly)/4E-03-2011 dated 18/12/2012 and Memo No.999-TET(Poly)/4E-03/2011 dated 18/12/2012 have sanctioned revised rates of pension/family pension **with effect from 1.4.2008** respectively to the employees and Principal & Lecturer of Govt. Polytechnic who retired/died in harness prior to 1/1/2006 as an extension of benefit of G.O. No. 200-F(Pen) dated 25/02/2009 issued by the Govt. of West Bengal ,Finance Department, Pension Branch.

2. The important points of both the above Memoranda to be kept in view while revising the pension/family pension of such categories of pensioners/family pensioners are summarized below:-

- (i) The process of consolidation of pension/family pension and the table indicating the consolidated pension/family pension with respect to existing pension/family pension as embodied in Govt of West Bengal, Finance Department, Memo No.200-F(Pen) dated 25/2/2009 and Annexure thereto (circulated vide this office circular No. Pen.Co-ordn./300/250 dated 27/3/3009) is to be followed for arranging payment of revised pension/family pension to the above categories of pensioner/family pensioner. The table shown in Annexure-I of the Memo dated 25/2/2009 ibid may be used only where the pensioner is in receipt of a single pension only.
- (ii) The minimum consolidated pension/family pension of above categories of pensioner/family pensioner will be **Rs. 3300/- p.m.** with effect from **1/4/2008**. In case of pensioners who are in receipt of more than one pension, the service pension shall be stepped up to Rs.3,300/-, if it falls below Rs.3,300 after consolidation. Other pension will simply be consolidated and it will not be stepped up, if it falls below Rs.3,300/-.
- (iii) The upper ceiling of pension and family pension has been increased from Rs.11200/- and Rs.6750/- to Rs.35,000/- and Rs.21,000/- respectively for both the categories of pensioners/family pensioners.

- (iv) The benefit of **additional pension/family pension** as contained in para 4.5 of Memo No.200-F(Pen) dated 25/2/2009 will also be admissible to such categories of pensioners/family pensioners. However, the stipulation as contained in Memo. No. 191-F(Pen) dated 16/4/2012(circulated vide No.Pen.Co-ordn/300/Vol-II/51/Vol-V/111/Vol-VI/50 dated 25/5/2012) that when a pensioner receives family pension along with his own service pension, the additional amount of pension for attaining the age of 80 years and above will be admissible only on service pension, will also be applicable for these categories of pensioners/family pensioners.
- (v) The provisions of Memo No.200-F(Pen) dated 25/2/2009 regarding consolidation of pension/family pension, regulation of relief etc. in respect of pensioners/family pensioners who are employed/re-employed or who have been permanently absorbed in Public Sector Undertakings/Autonomous bodies etc. and in case of extra-ordinary pension will also be applicable for these categories of pensioners/family pensioners.

3. Pension Disbursing Officers will make a suitable entry of revised pension/family pension, as determined above, in the both halves of P.P.O. Besides, Pension Disbursing Authorities will send an intimation regarding disbursement of such revised pension/family pension to this office in the form given at Annexure-II to Memo No. 200-F(Pen) dated 25/2/2009.

4. Moreover, it is informed that the Department of Technical Education & Training, Polytechnic Branch in their Memo. No. **1330-TET(Poly)4E-03/2011(Pt)** dated **18/12/2013**, received through letter No.10-TET(Poly) dated 3/1/2014, have also sanctioned revised rates of **Dearness Relief** to the categories of pre-1/1/2006 pensioners /family pensioners whose pension /family pension has been revised in terms of Memo. No. 995-TET(Poly)/4E-03-2011 and Memo No.999-TET(Poly)/4E-03/2011 both dated 18/12/2012 as well as to such categories of post 1/1/2006 pensioners /family pensioners whose pension/family pension has been regulated under Memo No.997-TET(Poly) & 1001-TET(Poly) both dated 18/12/2012 as below:-

Period for which payable	Rates of Dearness relief on revised pension/family pension
01/04/2008 to 31/05/2008	2%
01/06/2008 to 31/10/2008	6%
01/11/2008 to 28/02/2009	9%
01/03/2009 to 31/03/2009	12%
01/04/2009 to 30/11/2009	16%
01/12/2009 to 31/03/2010	22%
01/04/2010 to 30/11/2010	27%
01/12/2010 to 31/12/2011	35%
01/01/2012 to 31/12/2012	45%
01/01/2013 to 31/12/2013	52%
01/01/2014 onwards	58%

Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Further rates of dearness relief for such categories of pensioner/family pensioner will be at par with the rates as sanctioned by the Govt. from time to time for their pensioners/family pensioners.

5. All Pension Disbursing Officers are, therefore, requested to arrange revision of pension/family pension to the categories of pensioners/family pensioners who retired/died in harness prior to 1/1/2006 in terms of the Memo No. 200-F(Pen) dated 25/2/2009, keeping in view of the instruction given above and to make payment thereof with effect from 1/4/2008 along with dearness relief at the rates mentioned above, subject to adjustment of all payments made in this regard.
