Subject:- Revision of pension/family pension of pre 01.01.2016 pensioners/family pensioners of Haryana Government (7th CPC) w.e.f 01.01.2016 **clarification thereof.**

Sir/Madam,

I am directed to invite your kind attention to the Finance Department's Office Memorandum No.2/23/2016-1Pension Dated **10.01.2018** vide which it had been decided by the State Government to revise the pension/family pension in respect of all Haryana Government pensioners/family pensioners, who retired/died **prior to 01.01.2016** with effect from **1st January, 2016** followed by clarification memoranda of even number dated 30.01.2018/01.02.2018, 11/22.10.2018, 07.12.2018, 31.01.2019, 27.05.2019, 19.02.2020, 10.07.2020 & 24.07.2020.

Sometime past, retirees have made a request to amend/revise the Fitment Table No. 26 (GP-8700) & 27 (GP-8800) issued with OM No.2/23/2016-1Pension (FD) dated 10.01.2018, in reference of notification **No.1/20/2016-5PR (FD)** dated **14.07.2020** issued by Finance Department (Pay Revision Branch) for revision of pension/family pension.

Now, after due consideration, State Government has decided to amend/revise the **Fitment Table No. 26 (GP-8700) & 27 (GP-8800)** issued with OM No. 2/23/2016-1Pension (FD) dated **10.01.2018**, in reference of notification **No.1/20/2016-5PR(FD)** dated **14.07.2020** issued by Finance Department (Pay Revision Branch) for revision of pension/family pension of pre-2016 pensioners, **w.e.f 01-01-2016** and the same is annexured as **annexure 'A' and 'B'**.
