Instructions regarding the Declared Result of SAS Exam

1. For **New Candidates who have registered for the first time for Exam 1 of 2026**, the marks in each paper are displayed as follows:
 - Candidates securing **60 % or more marks and earning exemption**, their marks followed by "**(E)**" (e.g., 64(E), 72(E)).
 - Candidates securing **60 % or more marks but not earning exemption due to the sectional cut-off**, their marks followed by "**(NE)**" (e.g., 62(NE), 68(NE)).
 - Candidates securing **less than 60 marks** have only their marks displayed, without any notation.
 - In respect of **SC/ST/PwBD candidates**, the new candidates shall be required to secure a minimum of 45% marks to pass a paper and 55% marks to earn exemption, subject to obtaining at least 35% marks in each section of the paper.
2. For **Old Candidates who have registered prior to Exam 1 of 2026**, the marks in each paper are displayed as follows:
 - A candidate shall be declared to have passed the examination on securing an aggregate of 45% marks, irrespective of the marks obtained in individual sections in each papers.
 - In respect of **SC/ST/PwBD candidates**, a relaxation of **5%** in the aggregate qualifying marks is admissible. Accordingly, the minimum qualifying aggregate marks for such candidates shall be **40%**.
