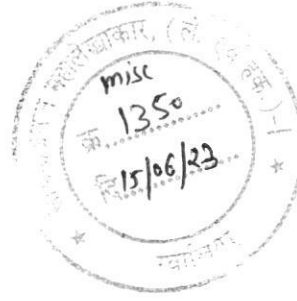

**Subject: Payment of Dearness Relief @ 42 % to Haryana Government pensioners and family pensioners w.e.f. 1<sup>st</sup> January 2023.**

The Governor of Haryana is pleased to enhance the Dearness Relief payable to Haryana Government pensioners and family pensioners, who are drawing their pension/family pension as per 7<sup>th</sup> pay/pension structure, from existing rate of 38 % to 42 % of the basic pension with effect from 1<sup>st</sup> January, 2023.

2. Enhanced DR and arrear shall be paid with the pension payable in the correct method. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored. All other conditions for payment of Dearness Relief to Pensioners & Family Pensioners on revised Pension & Family Pension contained in FD's instructions No. 2/23/2016-1 Pension dated 3<sup>rd</sup> March, 2017 shall remain same.

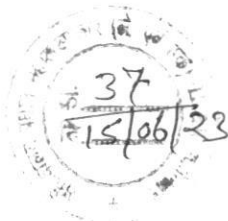

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) payable to Haryana Government employees, who are drawing their pay as per 7<sup>th</sup> Pay Commission structure, from existing rate of 38% to 42% of the basic pay with effect from 1<sup>st</sup> January, 2023.

2. Enhanced DA shall be paid with the pay of April, 2023 and arrear for the months of January, 2023 to March, 2023 shall be paid in the month of May, 2023. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
