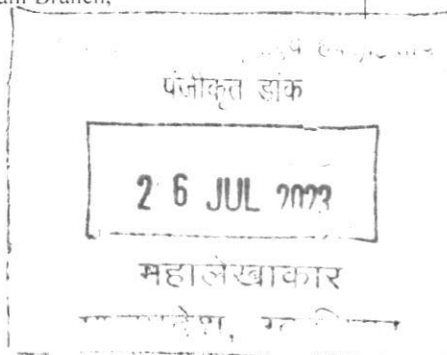

The undersigned is directed to refer Office Memorandum No. 1/3(1)/2008-E.II (B), dated the 10<sup>th</sup> April, 2023 of the Ministry of Finance, Department of Expenditure, Government of India regarding payment of Dearness Allowances (DA) to the employees of Central Government and Central Autonomous Bodies who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission and to inform that enhanced rate of DA from the existing rate of 212% to 221% of Basic Pay w.e.f. 01-01-2023 will be applicable for the employees of Central Government and Central Autonomous Bodies who have been continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission . This is also applicable for Tripura Judicial Service Officers and those retired from Tripura Judicial Service , whose basic pay/pension has not been revised in terms of Law Department's Memorandum No.F.1(1)/SECY/LAW/ MISC/2019/145-58, dated 30.09.2022.



**Subject: Revised rates of Dearness Allowance to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission**

The undersigned is directed to refer to this Department's O.M. No. 1/3(1)/2008-E.II(B) dated 12<sup>th</sup> October, 2022 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies, who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 212% to 221% of Basic Pay w.e.f. 01.01.2023.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(3)/2008-E.II(B) dated 29<sup>th</sup> August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.

3. The contents of this Office Memorandum may also be brought to the notice of all organisations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.
