Shri.Rahul MS, Clerk is promoted to officiate as **Auditor** in **Level 5** of Pay Matrix with effect from **03.01.2022** (01/01 and 02/01/2022 being Saturday and Sunday) or from the date of assumption of charge, whichever is later.

The official will have to pass the Departmental Examination for Auditors within six consecutive chances, falling due immediately after the promotion in accordance with the provisions of para 9.4.2 of Comptroller and Auditor General's Manual of Standing Orders (Admn.) Vol.I Third Edn. and failure to pass the Examination will entail reversion to Clerks' cadre. He will be permitted to appear for 3 more additional chances to clear the examination as reverted Clerk, which will have to be availed of within two years from the date of reversion. In the case of reverted Clerk who is unable to pass the Departmental Examination for Auditors even in the additional chances permissible to him, he will become eligible for consideration for promotion to the cadre of Auditor only after 5 years from the date of reversion.

If he intends to exercise option for fixation of pay in terms of FR 22(I)(a)(1), he should give the option in writing within one month from the date of promotion.

The above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in SLP(C) No.31288/2017.
