

Sub: Grant of Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners for the year 2014-15

Government of Kerala, as per GO(P) No.337/2015/Fin dated 7.8.2015 and as modified vide GO(P) 361/15/Fin dated 13.8.2015, have sanctioned Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners at the rates mentioned below:

Category	Rate of Special Festival Allowance
Service pensioners	Rs.870
Family pensioners	Rs.750
Pro-rata pensioners	Rs.800
Pro-rata Family pensioners	Rs.800
Ex-gratia pensioners	Rs.750
Personal Staff Pensioners	Rs.750
Retired Leprosy Patient Employees	Rs.750
Part-time Contingent Pensioners	Rs.750
Part-time Contingent Family pensioners	Rs.680
Compassionate Allowance pensioners	Rs.680
Personal Staff Family Pensioners	Rs.750

The Special Festival Allowance is admissible to those pensioners who retired from service prior to 1.4.2014.

The pensioners retired from service on or after 1.4.2014 but not eligible for bonus or such other allowances as per the above Government Order for want of 6 months continuous service during the financial year 2014-2015 are also eligible for the Special Festival Allowance. In their case, a self declaration to the effect that they

are not eligible for bonus or special festival allowance by virtue of their service during 2014-15 may be insisted upon before arranging payment.

The allowance sanctioned as per these orders shall be disbursed to the eligible Pensioners/Family Pensioners before 31.3.2016.

In the case of a Service Pensioner who is also in receipt of family pension, the special festival allowance is payable only on the basis of one of those pensions.

The special festival allowance sanctioned as per these orders is admissible to all State Pensioners/Family Pensioners except to the following categories.

1. All India Pensioners/Family Pensioners
2. Re-employed pensioners
3. Employed Family Pensioners
