Attention of all the Link Branches of the Public Sector Banks authorized to disburse pension under the Public Sector Bank Scheme is drawn to the approval granted by the Government for switching over from the manual pension payment order books to computerized pension payment order sheets for authorization of pension and other pensionary benefits.

Note of the above may be taken as this Directorate will commence the issue of computerized Pension Payment Order Sheets i.e. Disburser's Portion (Yellow) & Pensioner's Portion (Blue) in respect of employees retiring on superannuation/ voluntary/ invalid/compulsory/provisional pension (Rule 69) basis w.e.f. 1st August 2019.

Therefore, instructions with regards to the above may kindly be conveyed to all the branches under your control.

The Pension Payment Order issued by this Directorate in respect of Family Pension shall continue to be in the form of books until further issue of instructions separately.
