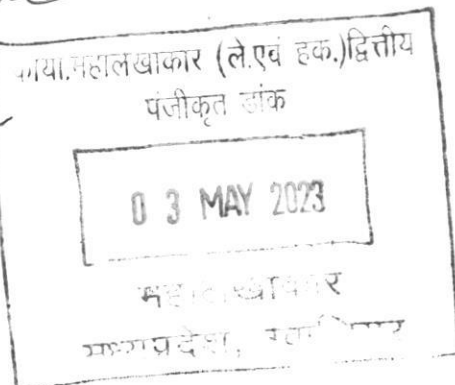

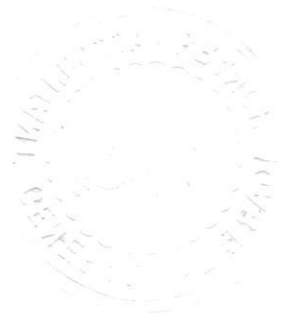

MEMORANDUM

Subject:- Revised rates of Dearness Allowance to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6th Central Pay Commission from 01.07.2022.

The undersigned is directed to refer Office Memorandum No. 113(1)2008-E-II (B), dated the 12th October, 2022 of the Ministry of Finance, Department of Expenditure, Government of India regarding payment of Dearness Allowances (DA) to the employees of Central Government and Central Autonomous Bodies who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6th Central Pay Commission w.e.f. 01.07.2022 and to inform that enhanced rate of DA from the existing rate of 203% to 212% of Basic Pay w.e.f. 01.07.2022 will be applicable for the employees of Central Government and Central Autonomous Bodies who have been continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6th Central Pay Commission. This is also applicable for Tripura Judicial Service Officers and those retired from Tripura Judicial Service, whose basic pay/pension has not been revised in terms of Law Department's Memorandum No. F.I(1)SECY/LAW/MISC/2019/145-58, dated 30.09.2022.
