## **INSTRUCTIONS TO THE CANDIDATE**

Candidate should bring the following **original certificates/testimonials** along with copies duly attested on the date of Document Verification in support of documents/testimonials submitted by them with the applications for scrutiny. Applications will be summarily rejected and not considered by the competent authority if original Sports certificates are not produced on the date of Document Verification.

1. **Proof of Age:** The date of Birth as recorded in the Matriculation Certificate or in a certificate recognized as equivalent to Matriculation. Birth certificates issued by Municipalities/Municipal Corporations may be accepted.
2. **Proof of Educational qualification:** Certificate/Mark sheet in support of the educational qualification issued by recognized Board/Council/University.
3. **Proof of Certificates for consideration under reserved category:** Candidate who claims to be in the category of SC/ST/OBC seeking age-relaxation must furnish requisite certificate from the competent authority.
4. Persons already in Government service should send their application through proper channel.
5. **Annexure IV (Form 1, 2, 3) and Annexure V:** The candidates who have not submitted copies of certificates awarded by the authorities mentioned in Annexure IV (Form 1, 2, 3 whichever is applicable) and Annexure-V in response to the advertisement at the time of submitting the application, the said documents are to be furnished on the date of Document Verification. In case of candidate, failing to do so, her/his candidature will be treated as cancelled without any further appeal/assigning any reason thereof. Further, the old format i.e., Form 'B' is not acceptable.
6. **Submission of Affidavit:** The candidate whose name/father's name etc. is found to be different in various certificate/testimonials submitted by him/her should submit an affidavit in original.

**Declaration of Playing Position:** Candidate applying for recruitment in the discipline of Cricket and Football should submit an undertaking in writing stating "Playing position in the discipline" positively on the date of Document Verification failing which the candidate will not be allowed to participate in the Fitness and Skill Test.

**Playing Kits:** The candidate is required to carry his/her playing kits at the time of Fitness Test and Skill Test.

**Reporting Time:** No candidate will be allowed for Fitness Test and Skill Test in case he/she fails to report within the specified time.

Candidate found taking recourse to any unfair means during the test or intentionally/unintentionally extending to or receiving from other candidates any unfair assistance shall render themselves liable to expulsion at the discretion of the authority.

No Candidate will be allowed to participate in the Fitness Test/Skill Test if they fail to furnish original documents on the date of document verification. The documents furnished in original will be scrutinized by the competent authority and returned to the candidates.

If any candidate secures less than 40% marks in Fitness Test, she/he will not be considered for the Skill Test.
