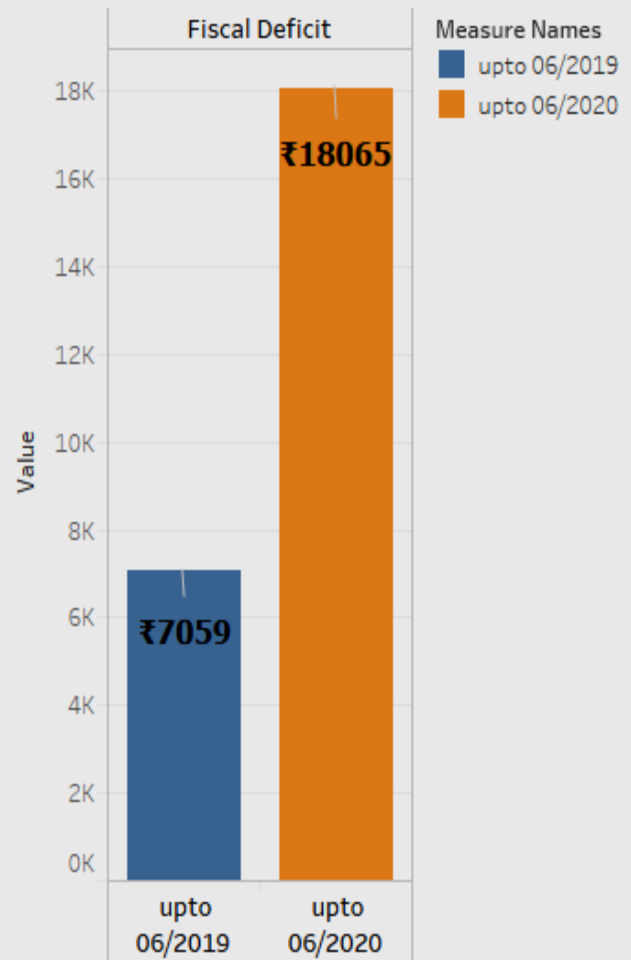
Tax Revenue upto 6/2020
(Amount in Crore)



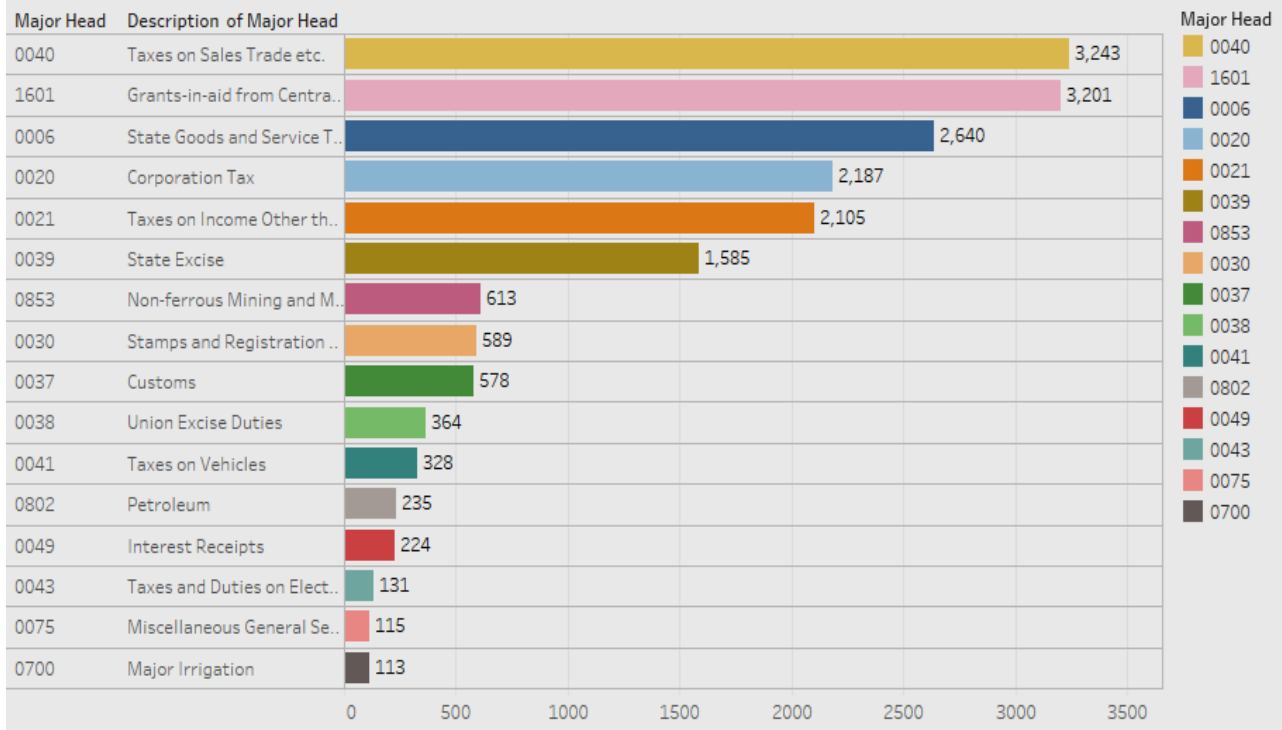
Revenue Deficit (Amount in Crore)



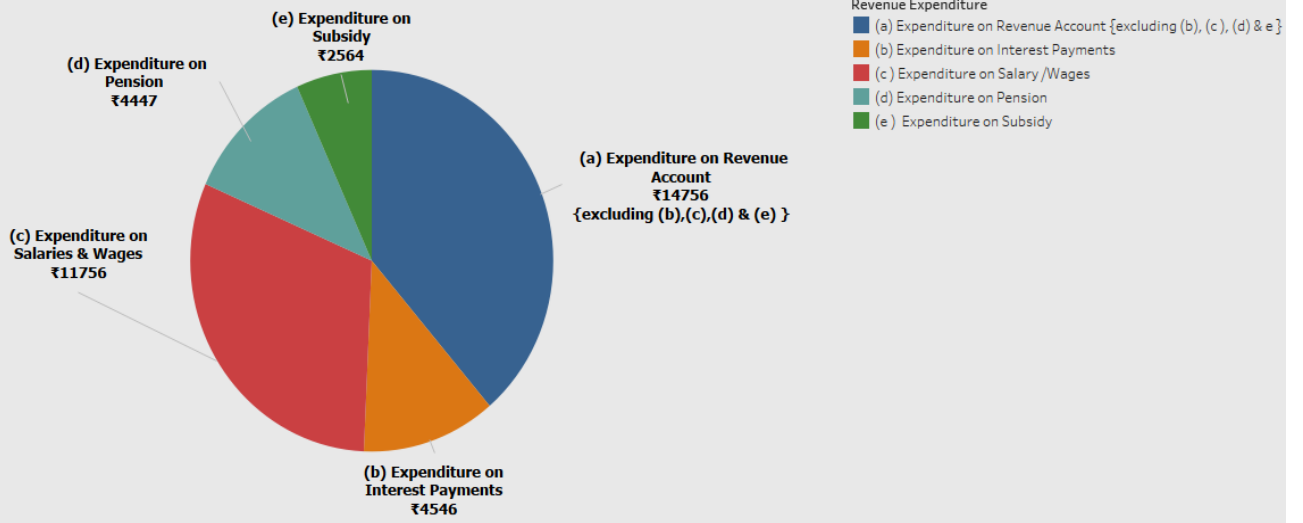
Fiscal Deficit (Amount in Crore)



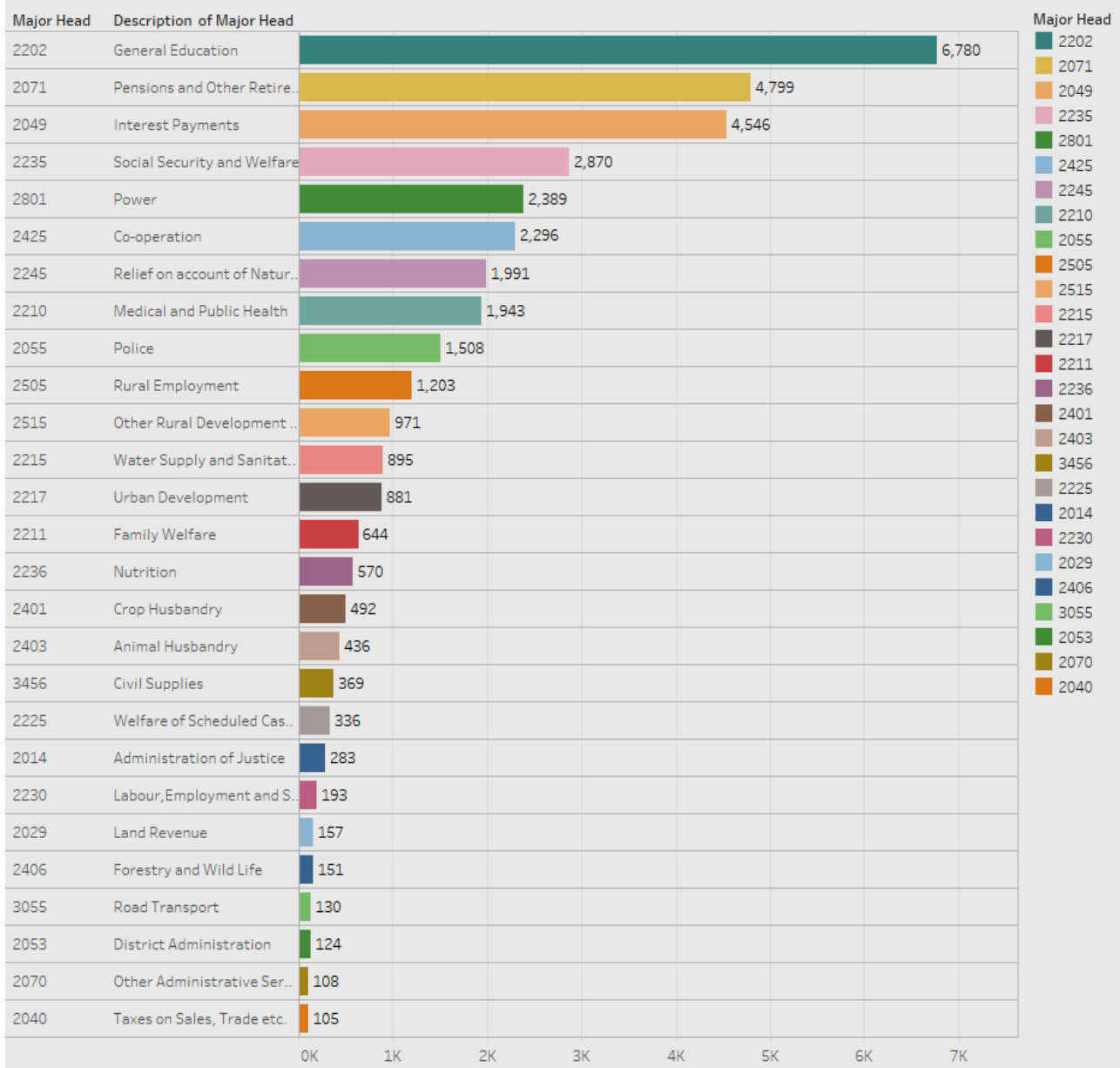

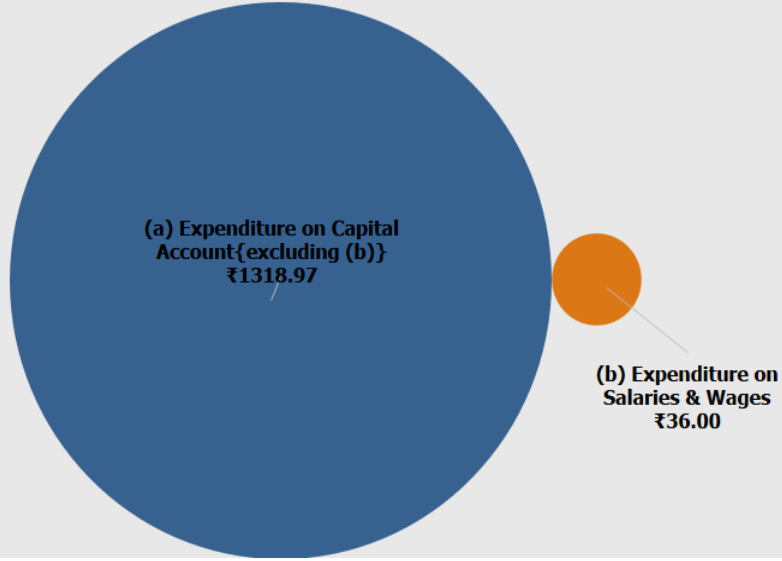

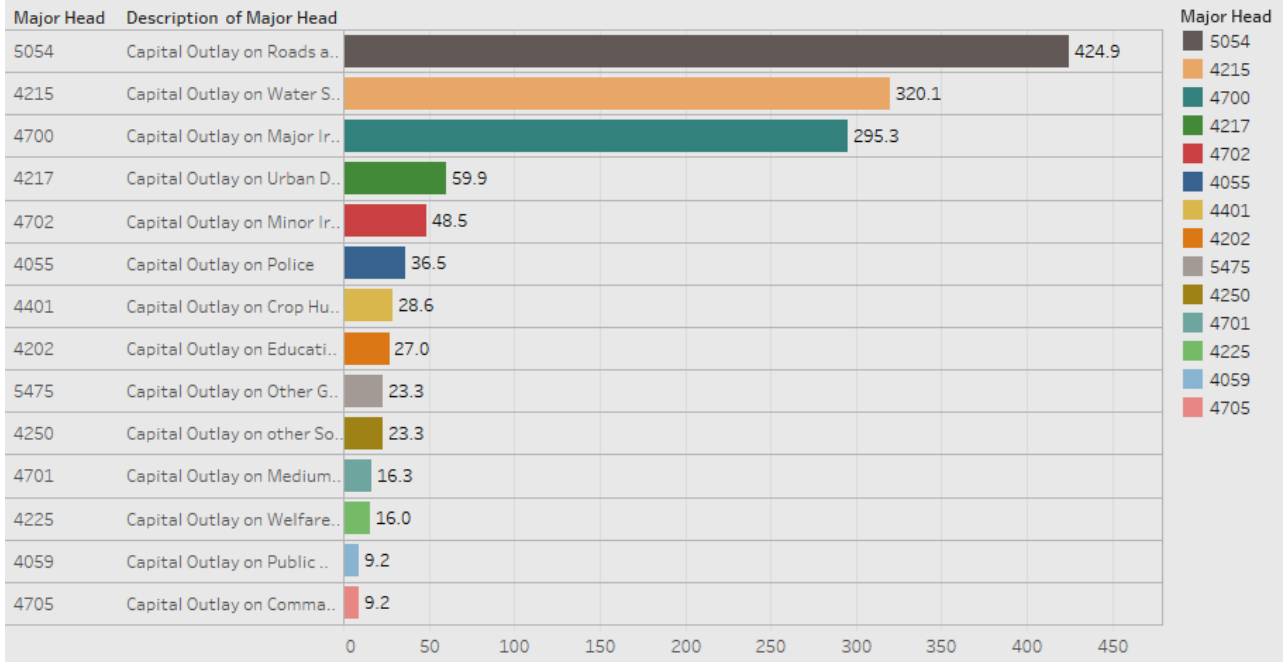


Capital Expenditure upto 6/2020

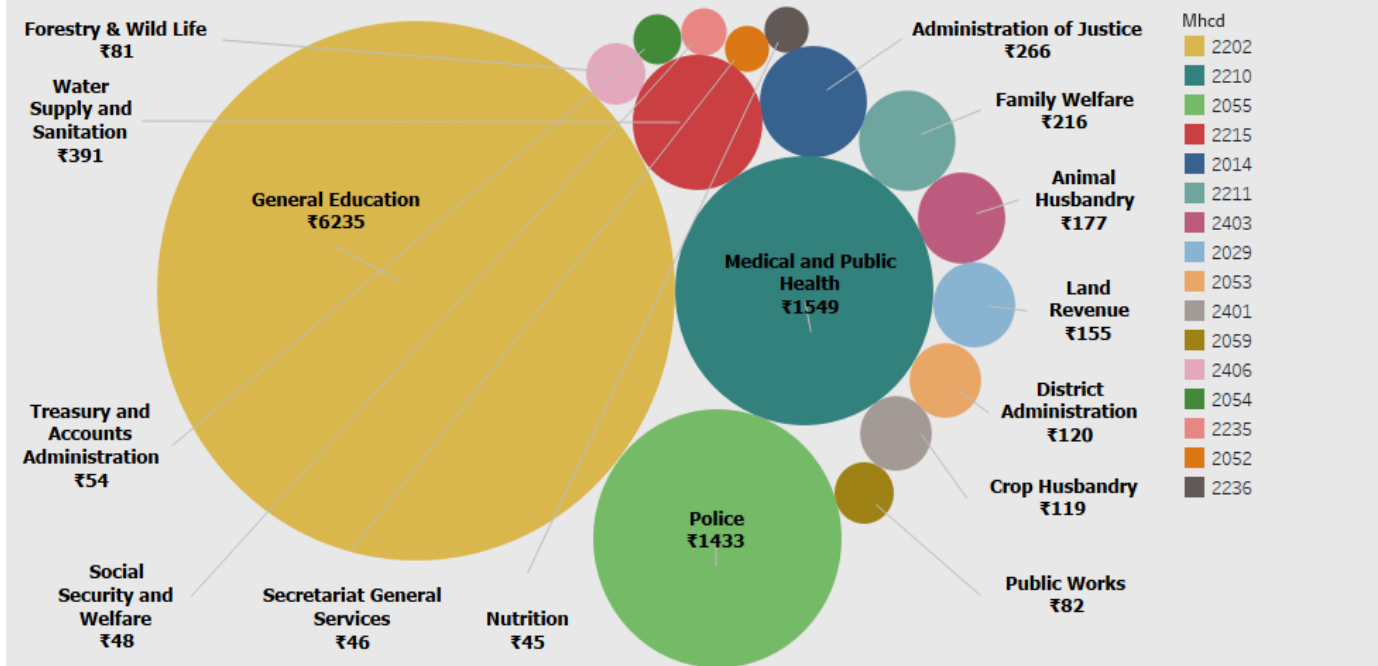
Capital Expenditure
