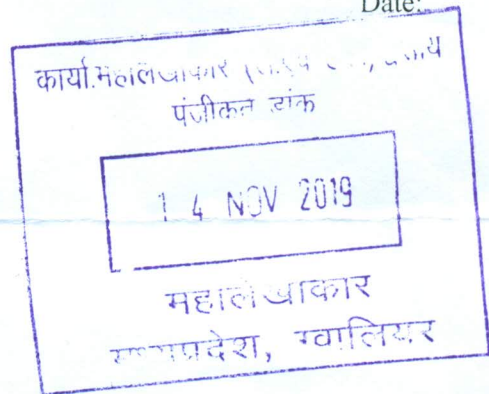

2	DRWs / MRWs / PTW / Fixed Pay employee and other similar workers engaged with prior concurrence of the Finance Department.	
3	DRWs / MRWs / PTW / Home Guard/ Fixed Pay employee and other similar workers engaged prior to 01-04-2004 without concurrence of the Finance Department.
