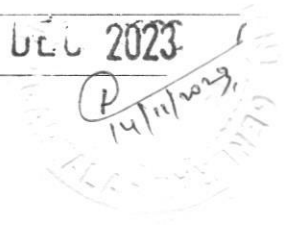

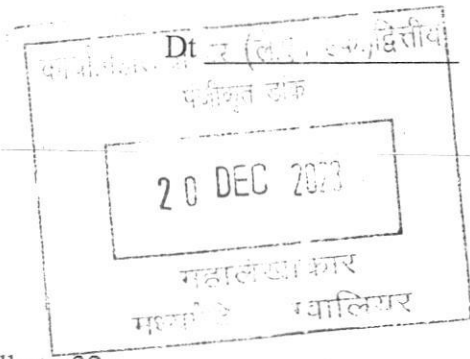

Subject:-Revision of Pension of Retired Judicial Officers/Family Pensioners of the Tripura Judicial Service in compliance to the order of Hon'ble Supreme Court of India dated 19.05.2023 in All India Judges Association Vs Union of India and Ors, in WP(C) 643 of 2015.


1. In continuation of the Memorandum issued vide No.F.1 (1)-SECY/LAW/MISE/2019 (Part-I)/222-253, dated, 09th August, 2023, the undersigned is directed to say that the following points shall stand included in the said Memorandum for Revision of Pension/ Family Pension of Retired Judicial Officers of the Tripura Judicial Service :-

(i) **Benefit of one increment to Judicial officers retiring on or after 01.01.2016** – The Judicial Officers who retired/ retires on or after 01.01.2016 shall have the benefit of one increment becoming due on the next day following the retirement. That increment shall be for the purposes of pension only and shall be subject to vertical ceiling of Rs.2,24,100/-.

(ii) **Dearness Relief** – Retired Judicial Officers/ family pensioners shall be entitled to get Dearness Relief (DR) on their revised basic pension/ family pension at the rate commensurate to the rate of Dearness Relief payable to the Central government employees from time to time w.e.f. 01.01.2016.

2. Other existing allowances for retired judicial officers/ family pensioners shall continue until further order to be passed by the Hon'ble Supreme Court of India in this regard.

In continuation of the Memorandum issued vide No.F.1 (1)-SECY/LAW/MISE/2019 (Part-I)/222-253, dated, 09th August, 2023, the undersigned is directed to say that the following points shall stand included in the said Memorandum for Revision of Pension/ Family Pension of Retired Judicial Officers of the Tripura Judicial Service :-

(i) **Benefit of one increment to Judicial officers retiring on or after 01.01.2016** – The Judicial Officers who retired/ retires on or after 01.01.2016 shall have the benefit of one increment becoming due on the next day following the retirement. That increment shall be for the purposes of pension only and shall be subject to vertical ceiling of Rs.2,24,100/-.

(ii) **Dearness Relief** – Retired Judicial Officers/ family pensioners shall be entitled to get Dearness Relief (DR) on their revised basic pension/ family pension at the rate commensurate to the rate of Dearness Relief payable to the Central government employees from time to time w.e.f. 01.01.2016.

2. Other existing allowances for retired judicial officers/ family pensioners shall continue until further order to be passed by the Hon'ble Supreme Court of India in this regard.


