The undersigned is directed to enclose herewith a copy of the office Memorandum issued from GOI, Ministry of Finance, Department of expenditure vide No.1/3(1)2008-E.II(B) dated 13<sup>th</sup> August, 2021 regarding rates of enhancement of DA to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6<sup>th</sup> Central Pay Commission w.e.f. 01.07.2021.

All Heads of Departments/Heads of Offices Concerned are, therefore, requested to arrange payment of DA as per the above enhanced rates of DA i.e from 164% to 189% w.e.f. 01-07-2021 to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6<sup>th</sup> Central Pay Commission.

This enhanced rate of DA is applicable as DA/DR on their pre-revised Pay/Pension from the same date and on the same terms and conditions in respect of serving members of Tripura Judicial Service and those retired from Tripura Judicial Service also.
