The Government of West Bengal, Judicial Department under their letter No. I/452744/2023-J/JD/V/2A-14/17 dated 08/11/2023 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 42% to 46% with effect from 01/07/2023**.
