The Government of West Bengal, Judicial Department under their letter No. I/629266/2025-J/JD/V/2A-14/17 dated 16/04/2025 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been enhanced from 53% to 55% with effect from 01/01/2025.
