Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges for the year 2021-2022

The Govt. of West Bengal, Department of Higher Education, Budget Branch in their Memo No. 63-Edn(B)/1M-12/2008 dated 19/05/2022 have sanctioned payment of ex-gratia grant of Rs.2700/- (Rupees two thousand seven hundred) only in lump per head to all teaching/non-teaching pensioners / family pensioners of State Aided Colleges including the holders of provisional pension who retired prior to 30.09.2021 and also the pensioners who retired or died after 30.09.2021 but prior to 01.09.2022 and are not eligible to receive ad-hoc bonus.

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with dearness relief as on 31st March 2022 did not exceed Rs.32000/-(Rupees thirty two thousand). The benefit is not admissible to those who are entitled to ad-hoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.2700/- (Rupees Two thousand seven hundred) only in lump per head.
- 4. The payment of ex-gratia as sanctioned in the Memo may be made to the Muslim Pensioners/family pensioners immediately on receipt of this circular and other than Muslim Pensioners/Family pensioners, the payment in this regard may be disbursed in between 19th September 2022 to 23rd September 2022.
