Divisional Accountants (Probationers) who have been declared to have completed the probation period vide this office order No. 137 dated 16/04/2025 (copy enclosed) are hereby directed to submit their options in the order of preference, for all stations for appropriately graded vacant divisions from the given list of vacant divisions. It may be noted that option received for only one station will not be considered. Any conditional option including option for a place with a particular division will not be considered. It is likely that the Division appropriate to their grade may not be available to accommodate them in the same station. In that case, they may be shifted outside the station nearby his/her option.
