**Subject:** Amendment of date of effect of Dearness Relief on pension/family pension to the Pensioners/Family Pensioners of the Teaching & Non-Teaching staff of Non-Govt. Sponsored/Aided Educational Institutions, etc. under Govt. of West Bengal

In partial modification of this office circular No.259/Vol-II/50 dated 07/06/2024, it is stated that Govt. of West Bengal, School Education Department, Planning & Budget Branch in their MemoNo.340-SED-18099/40/2020-PB SEC-Dept.of SE dated 20/06/2024 have modified the date of effect for payment of dearness relief with effect from 1/4/2024 instead of 1/5/2024 as was sanctioned under Memo. No. 166-SED-18099/40/2020-PB SEC-Dept. of SE dated 11/03/2024 for the pensioners /family pensioners of Government Aided Educational Institutions who are drawing pension/family pension at revised rates of pension on the basis Of Memo No.52/ES/P/P&B/10M-99/2019 dated 14/02/2020, circulated by this office vide No. Pen.Co-ordn/259 Vol-II/210 dated 27/04/2020.

Accordingly, all concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief @ 14% on revised rates of pension/family pension with effect from 01/04/2024 instead of 01/05/2024 to the above categories of pensioners/family pensioners.
