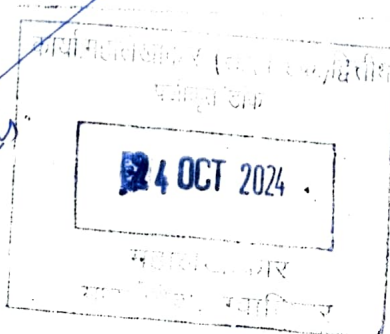

Sub : Grant of ex-gratia payment for the year 2023-2024 payable to the pensioner/family pensioners of the teaching and non teaching employees of Non-Govt. Educational Institution governed by DCRB' 81 scheme

It is informed that the Govt. of West Bengal, Higher Education Department, Budget Branch in their Memo no. 35-SE(B)/1M-12/2008 dated 15/03/2024 have sanctioned ex-gratia grant of Rs3200/-/- (Rupees three thousand two hundred) only in lump per head to all pensioners/family pensioners of the teaching and non teaching employees of Non Govt. Educational Institution guided under DCRB' 81 scheme (excluding DA Getting Schools and Sanskrit Tolls) including the holders of provisional pension who retired/died prior to 30-9-2023 and also the pensioners/family pensioners who retired or died after 30.09.2010 but prior to 1-9-2024 and are not eligible to receive ad-hoc bonus.

2. The above categories of pensioners/family pensioners whose basic pension/family pension plus relief on pension as on March 31, 2024 did not exceed Rs.35000/- (Rupees thirty five thousand) only are entitled to get this benefit.

3. All Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Ex-gratia grant of Rs.3200/- (Rupees three thousand two hundred) only in lump for the year 2024 to the above categories of pensioners/family pensioners subject to fulfillment of above conditions.

5. The charges are debitable to the head 2071-Pen. and other retirement benefit-01-Civil 109-Pension to Employees of State Aided Educational Institutions, during the current financial year.
