Subject: <u>Treatment of pension cases as pre-1/1/2016 pensioner/family pensioner, who retired/died-in-harness on 31/12/2015</u>.

In continuation to this office circular No. Pen. Co-ordn/345/162 dated 20/1/2020 and Pen. Co-ordn/345/195 dated 12/3/2020, it is to state that the Govt. of West Bengal vide their Finance Department, Pension Branch Memo. No. 51-F (Pen) dated 20/1/2020 have clarified that the pays of those Govt. employees who retired/died-in-harness on 31/12/2015, will not be revised in terms of West Bengal Services (Revision of Pay & Allowance) Rules, 2019 and hence they would come under the purview of G.O. No. 535-F (Pen) dated 1/10/2019, as applicable to the pre-1/1/2016 pensioners.

All concerned are, therefore, requested to keep note of the above fact and act accordingly.
