The Government of West Bengal, Judicial Department under their letter No. I/157662/2021 dated 02/11/2021, has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been **enhanced from 189% to 196% with effect from 01/07/2021.**

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.IV/59 dated 06/09/2021, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 196% to the above category of pensioners / family pensioners with effect from 01/07/2021 after proper adjustments of payment already made.

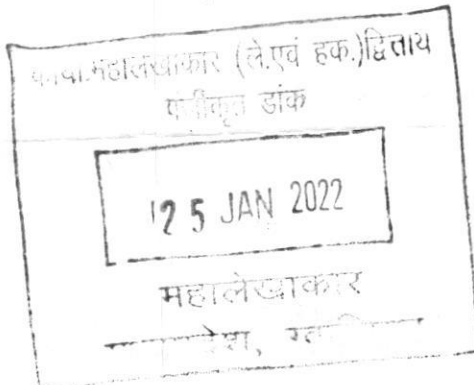
Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
