Subject:-Grant of revised rate of Dearness Relief @ 34% to Central Government Pensioners / Family Pensioners etc. effective from 01/01/2022

In continuation to this office circular No. Pen.Co-ordn./55 Vol.VI/142 Vol.III/65 Vol.IV/ 66 Vol.III/89 dated 29/10/2021, it is stated that Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare under their O.M. No 42/07/2022-P&PW(D) dated 05/04/2022 have sanctioned Dearness Relief at the rate of 34% with effect from 01/01/2022 in supersession of the rate mentioned in O.M. No 42/07/2021-P&PW(D) e-7330 dated 27/10/2021 to (i) Civilian Central Government pensioners/family pensioners including absorbee pensioners in PSU/Autonomous Bodies (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners / family pensioners (iv) Railway Pensioners / family pensioners (v) Pensioners who are in receipt of provisional pension (vi) The Burma Civilian Pensioners / Family Pensioners and (vii) Pensioners/families of displaced Government pensioners from Pakistan.

(a) CPF beneficiaries, their widows and eligible children who are in receipt of exgratia payment in terms of Department of Depar 45/52/97-P&PW(E) dated 16/12/1997 and revised subsequently vide ਰਿਹੀ 1/10/2012-P&PW(E) dated 27/06/2013.

(b) Burma Military pensioners / family pensioners

The retired officers of West Bengal Judicial Service and Harrisoners of such category whose pension/family pension has been regulate मध्यप्रदेशां खाहि। वर्षे dudicial Department Memo No 7012 - J and 7014 - J both dated 25/10/2010 would not come within the ambit of this circular and a separate circular letter in respect of such category of pensioners / family pensioners will be issued separately on enhancement of such applicable rate.

- 4. In the case of retired Judges of the High Court, separate circular will be issued on receipt of necessary order from the Ministry of Law and Justice.
- 5. Amount of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 6. It will be the responsibility of the pension disbursing authorities, including nationalized banks etc. to calculate the quantum of Dearness Relief payable in each individual case.
- 7. All concerned Pension Disbursing Officers are, therefore, requested to make necessary arrangement for payment of Dearness Relief @ 34% to the above eligible categories of pensioners/ family pensioners with effect from 01/01/2022, along with arrear of dearness relief following the above guideline, as applicable, after proper adjustment.
- 8. Charges for payment of above enhanced rate of dearness relief to the pensioners / family pensioners are debitable to the Government of India/Railway/Defence Accounts under the proper head of account as usual.
- 9. Receipt of the circular may please be acknowledged.
