Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.IV/133 dated 31/12/2021, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 203% to the above category of pensioners / family pensioners with effect from 01/01/2022 after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

Charges for payment are debitable to the Govt. of West Bengal, under head 2071 – Pension and other Retirement Benefits – 01 – Civil – 101 Superannuation and Retirement allowances etc.
