Subject: Age proof for grant of additional pension/family pension to the Bihar Government pensioners/family pensioners.

This is to state that the Government of Bihar in their Resolution No. B.-27/Pay Co.-137/2008-820 dated 23-09-2009, circulated under this office No. Pen. Co-ordn./Bihar/Vol.-VIII/Revision/185 dated 18-03-2010, had sanctioned additional pension/family pension to the old Bihar Government pensioners/family pensioners aged 80 years and above which has been continued vide their Resolution No. B. (27)Pe.Co.-(Rev.)22/2017--755 dated 20-10-2017, circulated under No. Pen. Co-ordn./Bihar/Vol.- IX/Revision-Detail/191 dated 19-01-2018.

O/o the Principal Accountant General (A&E), Bihar in their letter No. Pen-9-1122 dated 18-08-2022 has stated that any of the following documents may be accepted as the proof of age of the Bihar Government pensioners/family pensioners for payment of additional pension/family pension:

- i) Date of birth written in the Service Book of the pensioner.
- ii) Date of birth written in original proof of Matric Examination.
- iii) Date of birth written in the Aadhar Card.
- iv) Date of birth sent by the Pension Sanctioning Authority.

All pension disbursing authorities are requested to act upon accordingly for payment of additional pension/family pension to the old Bihar Government pensioners/family pensioners aged 80 years and above, in case the date of birth is not mentioned in the PPO/FPPO.
