#### AMENEMENT

In the said rules,-

- 1. In rule 11-A(2), for clause (1) and (2), the following shall substituted, namely:-
  - "(1) The revised pension of the retired Judicial Officer should be 50% of the minimum pay of the revised pay scale of the post held by

him at the time of the retirement, which shall be as Schedule 2 and 3:

Provided that at the time of revision and re-fixation, the existing pension shall be consolidated first as follows:-

(i)	Existing pension as on 1-1-2006		
(ii)	Dearness pension as on 1-1-2006		
(iii)	Dearness relief at prevalent rate on		
	both the existing basic pension and		
	Dearness pension as on 1-1-2006		

Provided further that the Judicial Officers, who have ceased to be in service due to death or retirement after 1st November, 2000 and prior to 1st January, 2006, their pension, which has been revised in accordance with the said rules, shall be revised by raising the same by 03.07 times w.e.f. 1st January, 2006 which shall not be less than 50% of the revised pay of revised pay scale equivalent to the last pay drawn at the time of his retirement.

(2) The revised pension shall be fixed at minimum 50% of the revised pay as mentioned in para (1) or consolidated pension as calculated above, whichever is higher:

Provided that such Judicial Officer who retired after 1<sup>st</sup> November, 2000 and prior to 1<sup>st</sup> January, 2006 and whose pension has been revised in accordance with the said rules,

I am directed to refer to this Ministry's letter No.45/08/2017-FF(P) dated 12.04.2018(copy enclosed) regarding 5% Dearness Relief to be paid to the freedom fighter pensioners w.e.f. 01.01.2018 and to say that recently Dearness Relief in respect of Central Government pensioners has been enhanced by 2% by the Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare, New Delhi's O.M. No.42/06/2018-P&PW(G) dated 18.09.2018. Hence the Dearness Relief admissible to the Central Freedom Fighters/spouse/daughter pensioners shall be enhanced from the existing rate of 5% to 7% w.e.f. 01.07.2018. All the banks are requested to calculate the arrears w.e.f. 01.07.2018 and disburse in the month of October, 2018. The revised amount of pension for various categories of pensioners after increase of 2% DR i.e. total 7% Dearness Relief will be as follows:
