1. Kindly refer the circular No. 3/2/92-Fin(Exp)/Part File-IV/16 02nd May, 2023 issued from the office of the Government of Goa, Finance (Expenditure) Department Secretariat, Porvorim-Goa, has conveyed the sanction for revision of Dearness allowance to the employee of State Government and its Autonomous bodies who continue to draw their pay and allowances in the pre-revised scale as per the **6th Central Pay Commission**.


As per the said circulars dated 10/04/2023 Government of Goa has decided to 'EXTEND' the office memorandum No.1/3(1)/2008-E-II(B) dated 10th April,2023 of Dearness allowance which is issued by Finance (Expenditure) department from time to time for the employees of State Government and its Autonomous bodies who continue to draw their pay and allowance in the pre-revised scale as per the **6th Central Pay Commission**.

2. It may be noted that in order to resolve the hardship being faced by the pensioner of Autonomous bodies/Corporations, it has been decided by the Government vide its order No.1/3(1)/2008-E-II(B) dated 12th October,2022 to extend the office memorandum of Dearness allowance which is issued by Finance (Expenditure) department from time to time for the employees of State Government and its Autonomous bodies who continue to draw their pay and allowance in the pre-revised scale as per the **6th Central Pay Commission**, for grant of Dearness Relief to pensioners of the Autonomous bodies/Corporations who are in pre-revised pension s per 6th Central Pay Commission, under their administrative control.

Since the order on relief contained in the above Finance (Expenditure) Department Memorandum are applicable to the employees/pensioners and Family Pensioners of the state Government and its Autonomous bodies/ Corporations who continue to draw their pay and allowance in the pre-revised scale as per the **6th Central Pay Commission**. I am to authorize you to pay Pensioners/Family pensioners of state Government and its Autonomous bodies/ Corporation the revised rates of Dearness Allowance which has been enhanced from time to time i.e. 221% w.e.f.01.01.2023.

- (a). Ex-gratia pensioners (Montepio pensioners, pensioners drawing pensions on account of service rendered to Portuguese colonies and institute Ultramarine Pensioners) drawing pensions under C/B/D and E series.
- (b). Pensao de Sangue pensioners.

- (c). Pensioners receiving pension under triple benefit scheme.
 - (d). Recipients of Ex-gratia i.e. Families of deceased pensioners/employees who were governed under EFU.
 - (e). Pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under pension payment series T and E.B.
3. In case of Goa State Government Pensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
 4. This Dearness relief is not applicable to the following class of pensioners.
 - a. Pensioners drawing pension, which is granted after Independence for Political consideration (Ex-Rulers).
 - b. Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
 - c. Pensioners of other states (PAO) Suspense) for whom separate orders are applicable.
 - d. M.L.A. Pensioners.
 - e. Freedom Fighters of Govt. of Goa.
 5. Instructions issued from time to time by this office as regards to payment of relief should be observed.
 6. Wide Publicity may be given to this circular letter by displaying a copy on the office notice board or other permanent place in your office.
 7. Pensioners who have drawn part payment of their pension through Treasury Office after 01/01/2017 and have subsequently opted for payment of their pension through Bank may also be paid arrears from the date of their retirement or from 01/01/2017 whichever is earlier without waiting for any individual orders from this office.





Pensioners who have drawn part payment of their pension through Treasury Office after 01/01/2017 and have subsequently opted for payment of their pension through Bank may also be paid arrears from the date of their retirement or from 01/01/2017 whichever is earlier without waiting for any individual orders from this office.

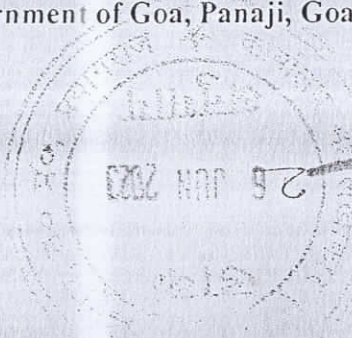

Subject:- Dearness Allowance/Dearness Relief.

The undersigned is directed to refer to this Department's O.M. No. F(PR)-53/2017/55 dated 23rd December, 2022 and to say that the Governor of Meghalaya is pleased to decide that the Dearness Allowance/Dearness Relief payable to all categories of State Government employees/pensioners and family pension holders shall be enhanced from the existing rate of 32% to 36% with effect from 1.1.2023.

2. These orders shall also apply to the members of the work-charged establishment and casual workers, other than Bungalow Peons, holding posts in the pay levels as admissible to the employees of corresponding categories under the regular establishment/services/posts.
3. The Dearness Relief under these orders shall remain suspended if the pensioners/family pensioners are employed/re-employed under the State/Central Government or employed/re-employed/permanently absorbed in the State's or Central Government's Company, Corporation, Undertaking or Autonomous Body. It shall, however, be revived after the spell of such employment/re-employment.
4. The payment on account of Dearness Allowance/Dearness Relief involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
5. The payment on account of the Dearness Allowance/Dearness Relief sanctioned herein shall be debited to the respective heads of accounts from which the employees draw their salary and the pensioners/family pension holders, their pension.

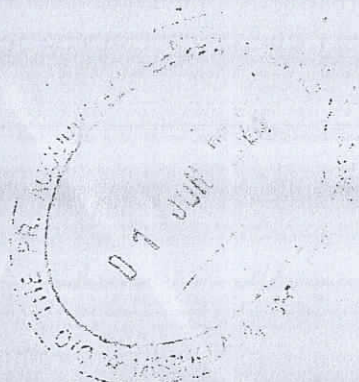


