

विषय:- वित्त विभागीय संकल्प संख्या-2140, दिनांक-28.02.2024 के द्वारा बिहार न्यायिक सेवा के पदाधिकारियों को विभिन्न भत्ता/सुविधाओं की दी गई स्वीकृति के संबंध में स्पष्टीकरण।

वित्त विभागीय संकल्प संख्या-2140, दिनांक-28.02.2024 के द्वारा बिहार न्यायिक सेवा के पदाधिकारियों को द्वितीय राष्ट्रीय न्यायिक वेतन आयोग की अनुशंसा के उपरांत माननीय सर्वोच्च न्यायालय, नई दिल्ली द्वारा दिनांक-04.01.2024 को पारित आदेश के आलोक में विभिन्न भत्ता/सुविधाओं की स्वीकृति दी गई है।

उक्त स्वीकृति के उपरांत माननीय उच्च न्यायालय के अंतर्गत गठित Committee for Service Condition of District Judiciary (CSDJ) की बैठक दिनांक-28.02.2024 को विभिन्न हित धारकों एवं बिहार न्यायिक सेवा एसोसिएशन से विचार-विमर्श के उपरांत विधि विभागीय पत्रांक-1760 दिनांक-06.03.2024 के द्वारा कतिपय बिंदुओं को स्पष्ट किये जाने की अनुशंसा की गई है।

उक्त आलोक में वित्त विभागीय संकल्प के निम्नलिखित प्रावधान को निम्नवत् स्पष्ट किया जाता है :-

- क. **शिशु शिक्षा भत्ता:-** शिशु शिक्षा भत्ता प्रति शिशु प्रतिमाह रु० 2,250/- (नियत) की दर से अधिकतम दो बच्चों हेतु अनुमान्य है। जिन मामलों में शैक्षणिक संस्थान के प्रधान से प्रमाण पत्र प्राप्त नहीं किया जा सके, वैसे मामलों में संबंधित न्यायिक पदाधिकारी द्वारा रिपोर्ट कार्ड अथवा शुल्क रसीद (ई-रसीद सहित) को स्व-प्रमाणित कर प्रस्तुत करने पर दावे का भुगतान लिया जा सकेगा।
- ख. **वाहन/परिवहन भत्ता :-** संकल्प के द्वारा प्रावधानित परिवहन भत्ता के साथ-साथ ईंधन (डीजल/पेट्रोल) भत्ता भी दिनांक- 01.01.2016 के प्रभाव से अनुमान्य है।
- ग. **होम अर्दली/घरेलु सहायक भत्ता :-** जिन न्यायिक पदाधिकारी को 01.01.2016 के पूर्व यह भत्ता प्राप्त हो रहा था, उन्हें 01.01.2016 के प्रभाव से, और जिन न्यायिक पदाधिकारी को 01.01.2016 के पूर्व यह भत्ता प्राप्त नहीं हो रहा था, उन्हें 01.01.2020 से, तथा सेवानिवृत्त पदाधिकारियों (पेंशनरों/पारिवारिक पेंशनरों) को दिनांक-01.01.2016 अथवा सेवानिवृत्ति/पारिवारिक पेंशन प्रारंभ होने की तिथि, जो बाद में हो, से संकल्प द्वारा प्रावधानित दर पर अनुमान्य किया जाएगा। पेंशनरों/पारिवारिक पेंशनरों को भुगतान तत्काल बिना स्वप्रमाणन के किया जा



सकेगा, परन्तु संकल्प निर्गत की तिथि के एक वर्ष के अंदर संलग्न प्रपत्र में स्व-प्रमाणन प्रमाण पत्र संबंधित कोषागार/बैंक में पेंशनरों/पारिवारिक पेंशनरों के द्वारा जमा किया जाना आवश्यक होगा।

Sub: Clarification regarding sanction of various allowances/facilities granted to Bihar Judicial Service Officers, vide Department of Finance, Resolution No. 2140, dated 28.02.2024.

Vide Department of Finance, Resolution No. 2140, dated 28.02.2024, sanction of various allowances/facilities has been accorded to Bihar Judicial Service Officers in the light of the Order passed by the Honourable Supreme Court, New Delhi on 04.01.2024, after the recommendations of the Second National Judicial Pay Commission.

After the above sanction, after discussion with various stakeholders and Bihar Judicial Service Association in the meeting of the Committee for Service Condition of District Judiciary (CSDJ) constituted under the Honourable High Court, held on 28.02.2024, it has been recommended to clarify some points, through Legal Department letter no. 1760 dated 06.03.2024.

In the light of the above, the following provisions of Department of Finance Resolution is clarified as below:

- a) **Children Education Allowance:** Children Education Allowance is permissible at the rate of Rs.2,250/-(fixed) per month per child for a maximum of two children. The cases in which certificate from the head of the educational institute cannot be obtained, payment of claim can be availed by producing the report card or fee receipt (including e-receipt) self-certified by the concerned Judicial Officer.
- b) **Conveyance/Transport Allowance:** Along with Transport Allowance as provided through the Resolution, Fuel (Diesel/Petrol) Allowance is also permissible w.e.f. 01.01.2016.
- c) **Home Orderly / Domestic Help Allowance:** This allowance shall be permissible w.e.f. 01.01.2016 to those Judicial Officers who were receiving this allowance before 01.01.2016, w.e.f. 01.01.2020 to those Judicial Officers who were not receiving this allowance before 01.01.2016 and w.e.f. 01.01.2016 or from the date of retirement/commencement of family pension, whichever is later, to retired officials (Pensioners/Family Pensioners), at the rates as provided in the Resolution. Payment to pensioners/family pensioners can be made immediately

without self-certification, but it will be mandatory to submit the self-certification certificate by the pensioners/family pensioners, in the enclosed proforma, to the concerned treasury/bank within one year from the date of issue of the Resolution.
