Subject: Grant of Dearness Relief to the West Bengal Govt, pensioners/family pensioners @ 18% drawing pension at revised rate consequent on implementation of WBS (ROPA), 2019 and @ 171% to the pensioners/family pensioners drawing pension at the pre-revised rate i.e. as per WBS (ROPA) 2009, both w.e.f. 1/4/2025.

In continuation to this office circulars No. Pen. Co-ordn/93 Vol. V1/59 dated 25/6/2024, it is stated that the Govt. of West Bengal, Finance Department (Audit Branch), in their Memo no. 1132-F (P<sub>2</sub>) dated 25/3/2025 (copy enclosed), have sanctioned revised rates of dearness relief w.e.f. 01/04/2025 @ 18% payable to the pensioners/family pensioners on basic pension/family pension, which are revised in terms of their Memo. No. 535-F (Pen) or 536-F (Pen) both dated 1/10/2019 and @ 171% payable to the pensioners/family pensioners who are drawing basic pension/family pension at the pre-revised rate *i.e.* in terms of their Memo. No. 200-F (Pen) or 201-F (Pen) both dated 25/2/2009, in supersession of the respective rates allowed previously.

Payment of relief on pension/family pension involving a fraction of a rupec shall be rounded off to the nearest rupee in each case.

All Pension Disbursing Officers are, therefore, requested to make necessary arrangements for payment of dearness relief at the rates as contained in the enclosed memo, dated 25/3/2025 to all eligible West Bengal Govt, pensioners/family pensioners after proper adjustment.

In this context, it is reiterated that separate circulars will be issued with regard to grant of dearness relief on pension/family pension to the teaching and non-teaching pensioner/family pensioners of Non-Govt. Educational Institution and Non Govt. Colleges on receipt of specific orders from the respective Administrative Departments.

Accountants General of other States are requested to arrange extra copies of the said Govt, order at their end, if necessary, for circulation within their State.

#### MEMORANDUM

Sub Grant of Dearness Allowance to State Government Employees and the employees of Government aided Educational Institutions, employees of Statutory Bodies, Government Undertakings, Panchayats including Panchayat Karmee, Municipal Corporations / Municipalities, Local Bodies etc. and also Dearness Relief to the Pensioners / Family Pensioners.

The question of enhancement of (i) Dearness Allowance in respect of Government employees, the teaching and non-teaching employees of Government aided Educational Institutions, employees of Statutory Bodies, Government Undertakings, Panchayats including Panchayat Karmee, Municipal Corporations / Municipalities, Local Bodies etc. and (ii) Dearness Relief on the pension / family pension has been under consideration of the Government for some time past.

- After careful consideration, the Governor has been pleased to decide the following:
- 1. The whole time State Government employees shall draw Dearness Allowance @ 18% of basic pay with effect from 01/04/2025. The calculation of Dearness Allowances shall be made taking into account the revised basic pay and NPA, if any, but it shall not include any other type of pay.
- The Deamess Allowance as sanctioned at (I) above in respect of State Government employees shall be admissible to the teaching and non-teaching employees of Government aided Educational Institutions, employees of Statutory Bodies, Government Undertakings, Panchayats including Panchayat Kamisee, Municipal Corporations / Municipalities, Local Bodies etc. The respective Administrative Department may sanction the benefit of Deamess Allowance @18% of revised basic pay with effect from 01/04/2025 to the employees under their control without making any further reference to Group-P2 of this Department.
- III. (a) The State Government Pensioners/ Family Pensioners shall draw Dearness Relief @18% of revised basic pension/ revised family pension with effect from 01/04/2025.
  - (b) It will be the responsibility of the Pension Disbursing Authority to calculate the quantum of Dearness Relief on revised Pension / revised family Pension payable to each individual case.
  - (c) For the purpose of payment of Dearness Relief sanctioned herein, the Principal Accountant General (A&E), West Bengal, will issue authority to the Public Sector Banks in Kolkata and the Accountant General of other States.
  - (d) The Treasury or Sub-treasury Officers in this State will give effect to this order without the authority of the Accountant General (A&E), West Bengal.

- IV. The Dearness Relief as sanctioned at (III)(a) above for the State Government Pensioners / Family Pensioners shall also be admissible to the Pensioners / Family Pensioners of State aided Non-Government Educational Institutions, Statutory Bodies / Government Undertakings / Panchayats, Municipal Corporations/ Municipalities, Local Bodies etc., who are in receipt of revised Pension/ revised Family Pension. The respective Administrative Department may sanction the benefit of Dearness Relief @18% of revised Pension / revised Family Pension with effect from 01/04/2025 to the Pensioners/ Family Pensioners concerned under their control without making any further reference to Pension Branch of this Department.
- V. (a) The rate of Dearness Allowance in respect of the employees mentioned in para (1) above who are drawing pay in the pre-revised pay structure as per recommendation of the 5° Pay.
   Commission shall be enhanced from 161% to 171% with effect from 01/04/2025.
  - (b) The pensioners/ family pensioners still drawing pre-revised pension / family pension (As per ROPA 2009) will get Dearness Relief @171% with effect from 01/04/2025 till their pension / family pension is revised.
- VI. The Dearness Allowance/Dearness Relief sanctioned herein shall be rounded off to the nearest nipee in each case.
- VII. In the case of Public Undertakings/ Statutory Bodies, the additional expenditure for sanction of Dearness Allowance and Dearness Relief should be borne by such Undertakings / Bodies themselves out of their own resources or out of financial assistance provided to them in the budget and no additional financial assistance will be given to them on that account.
- VIII. There will be a further ad-hoc increase in the Daily Rate of Wages by Rs. 22/- (Rupees Twenty Two) only with effect from 01/04/2025 for the daily rated workers under the Government whose wages are not regulated by any Statutory provisions like the Minimum Wages Act, etc.
