

Sub: Revision of rates of Dearness Allowance/ Dearness Relief to the serving State Government Employees/State Government Pensioners/Family Pension Holders/Extra Ordinary Pension Holders/Compassionate Family Pension Holders effective from 01/07/2025, applicable for revised pay scale as per A.S.(ROP) Rules, 2017.

The undersigned is directed to refer to Finance Department's OM vide No. FEG. 2498/2017/399 dated 04/04/2025 and Executive Order vide No. FEG.2498/2017/412 dated 04/06/2025 on the subject mentioned above and to say that the Governor of Assam is pleased to decide that the rates of Dearness Allowance (D.A.)/Dearness Relief (D.R.) payable to the State Government employees and the pensioners who are entitled to draw pay & pension as per A.S. (ROP) Rules, 2017 shall be admissible as per rate shown below:

Period from which payable	Rate of D.A./D.R. enhanced	Rate of D.A./D.R. per mensem
From 01/07/2025	3%	58% of Basic Pay/Basic Pension

Note: The payment on account of D.A./D.R. involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

- 1) The order shall apply to Government employees who are brought over to the revised scale of pay w.e.f. 01/04/2016 and to those who elected to retain the scale of pay that prevailed prior to 01/04/2016. In case of the former, pay for the purpose of D.A. will be as defined in F.R. 9(21)(a)(i) including stagnation increment. Those Government employees who exercised option to retain the scale of pay that existed prior to 01/04/2016 shall continue to draw the D.A. as is appropriate to the pay scales in force on 31/03/2016.
- The orders shall also be applicable to those Work Charged (WC) and Muster Roll (MR) employees/workers drawing minimum pay scales as per O.M. No. FEC(II)4/2014/414 dated 03/10/2019.
- 3) The rate of Dearness Relief for Extra Ordinary Pension Holders and Compassionate Family Pension Holders shall be governed by Finance Department's Executive Order No. FEG.2498/2017/412 Dated 04/06/2025 as per which the enhanced rate of Dearness

dief (D.R.) for extra-ordinary pension holders and compassionate pension holders hall be maximum of 3% in a financial year.

- 4) The amount sanctioned shall be classified as D.A./D.R. and the expenditure for the purpose will be debitable to the detailed head of Salary, Wages or Pension under respective head of account from which Govt. employees draw their pay and the Pensioners draw their pension.
- (i) The enhanced rate of 58% D.A./D.R shall be paid along with monthly pay/pension for the month of October 2025, in November 2025.
 - (ii) The arrear D.A/D.R. with effect from 01/07/2025 to 30/09/2025 shall be paid in three equal installments in the months of December 2025, January 2026 and February 2026 through Bank Accounts of the Employees/Pensioners. The arrear for the month of July, 2025 will be paid in December, 2025, for the month of August, 2025 will be paid in January, 2026 and that of September, 2025 will be paid in February, 2026.
 - (iii) State Govt. employees whose superannuation was due in the period w.e.f. July, 2025 to September, 2025 may be allowed enhanced rate (58%) of D.A. while computing their leave encashment benefit.
- 6) The Treasuries and Sub-Treasuries in Assam/Authorized Public Sector Banks are requested to arrange for the payment of Dearness Relief to the Pensioners/Family Pension Holders/Extra Ordinary Pension Holders/Compassionate Family Pension Holders on the basis of this Executive Order.

- 1) The order shall apply to Government employees who are brought over to the revised scale of pay w.e.f. 01/04/2016 and to those who elected to retain the scale of pay that prevailed prior to 01/04/2016. In case of the former, pay for the purpose of D.A. will be as defined in F.R. 9(21)(a)(i) including stagnation increment. Those Government employees who exercised option to retain the scale of pay that existed prior to 01/04/2016 shall continue to draw the D.A. as is appropriate to the pay scales in force on 31/03/2016.
- 2) The orders shall also be applicable to those Work Charged (WC) and Muster Roll (MR) employees/workers drawing minimum pay scales as per O.M. No. FEC(II)4/2014/414 dated
- 3) The rate of Dearness Relief for Extra Ordinary Pension Holders and Compassionate Family Pension Holders shall be governed by Finance Department's Executive Order No. FEG.2498/2017/412 Dated 04/06/2025 as per which the enhanced rate of Dearness

clief (D.R.) for extra-ordinary pension holders and compassionate pension holders shall be maximum of 3% in a financial year.

- 4) The amount sanctioned shall be classified as D.A./D.R. and the expenditure for the purpose will be debitable to the detailed head of Salary, Wages or Pension under respective head of account from which Govt. employees draw their pay and the Pensioners draw their pension.
- (i) The enhanced rate of 58% D.A./D.R shall be paid along with monthly pay/pension for the month of October 2025, in November 2025.
 - (ii) The arrear D.A/D.R. with effect from 01/07/2025 to 30/09/2025 shall be paid in three equal installments in the months of December 2025, January 2026 and February 2026 through Bank Accounts of the Employees/Pensioners. The arrear for the month of July, 2025 will be paid in December, 2025, for the month of August, 2025 will be paid in January, 2026 and that of September, 2025 will be paid in February, 2026.
 - (iii) State Govt. employees whose superannuation was due in the period w.e.f. July, 2025 to September, 2025 may be allowed enhanced rate (58%) of D.A. while computing their leave encashment benefit.
- 6) The Treasuries and Sub-Treasuries in Assam/Authorized Public Sector Banks are requested to arrange for the payment of Dearness Relief to the Pensioners/Family Pension Holders/Extra Ordinary Pension Holders/Compassionate Family Pension Holders on the basis of this Executive Order.
