- In case of Goa State Freedom Fighters/Family Pensioners drawing pension in other States, the instructions contained in above Letter may be issued to all the Treasuries/Sub-Treasuries/P.A.O where they are drawing their monthly pension.
- 4. This Dearness Relief is only applicable to the Goa State Freedom Fighter Pensioners/ Family Pensioners.
