

- It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Temporary Increase payable in each individual case.
- 8. All Accountant General of the respective States Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensioners from their State Treasures, Including Public Sector Banks.
- 9. Concerned Board, Corporation or organization will be free to give benefits of this resolution to their employees as per their financial strength. For this purpose the State Government will not give any kind of additional grant.
