Sub: Enhancement in the rates of Dearness Relief w.e.f. 1st July 2024 to the Pensioners/ Family Pensioners of the State Government, revised/effective from 01.01.2016 - reg.

Vide Planning-Cum-Finance Department, Resolution No. 218/Vi. dated 18.01.2017, revision of pension has been permitted to the pensioners/family pensioners of the State Government in accordance with the pension revision sanctioned w.e.f. 01.01.2016 by the Central Government to their pensioners/family Pensioners consequent to Seventh Pay Revision. In Para 9.1 of the above Resolution, Dearness Relief has been permitted in accordance with the Central Government.

- Vide Government of India, Ministry of Public Grievances and Pension, letter no. 42/02/2024-P&PW(D) dated 30.10.2024, it has been decided to increase the present rate of dearness relief of 50% (Fifty Percent) to 53% (Fifty Three Percent) w.e.f. 01.07.2024 to Central Government Pensioners/Family Pensioners, in the revised pay scale/pay structure (Seventh Pay Scale).
- 3. In the above context, after due consideration, decision has been taken to revise the rate of dearness relief permissible at present to the pensioners/family pensioners of the State Government, in accordance with the Central Government, as below:

"Dearness Relief of 53% (Fifty Three Percent) of basic pension may be sanctioned w.e.f. 01.07.2024 to those pensioners/family pensioners of the State, whose basic pension has been revised (Seventh Pay Revision) w.e.f. 01.01.2016 vide Department of Finance, Resolution No. 218/Vi. dated 18.01.2017".

 The sanction of the Council of Ministers on this proposal has been given in item no.02 of the meeting dated 24.12.2024 in continuation to the Department of Finance, Document Memo No. 2750/Vi. dated 13.12.2024

Sub: Enhancement in the rates of Dearness Relief to the Pensioners/Family Pensioners of the State Government, in unrevised pay scale (Sixth Central Pay Scale), w.e.f. 01.01.2024 - reg.

Vide Department of Finance, Resolution No. 660/Vi. dated 28.02.2009, sanction has been accorded for Unrevised (Sixth Pay-Scale) Central Pension/Family Pension to State Government pensioners/family pensioners w.e.f. 01.01.2006, like the Central Government pensioners/family pensioners. As per para-17 (a) (b) of the above Resolution, Dearness Relief at central rate has been sanctioned to the pensioners/family pensioners.

- 2. As mentioned above, Dearness Relief is permissible to State Government pensioners/family pensioners also w.e.f. 01.01.2006 (Sixth Pay-Scale) like the Central Government pensioners. At present, Dearness Relief of 230% (Two Hundred and Thirty Percent) is permissible to those State Government pensioners/family pensioners, who are receiving pension in unrevised pay scale (Sixth Pay-Scale).
- 3. Revision of Dearness Allowance in terms of the benefits of Sixth Pay Revision has been done by the Central Government to its employees w.e.f. 01.01.2024 and in light of the above, sanction has been accorded to increase the rate of Dearness Allowance from 230% (Two Hundred and Thirty Percent) to 239% (Two Hundred and Thirty Nine Percent) in sixth unrevised pay scale vide Government of India, Ministry of Finance (Expenditure) letter no. 1/3(1)/2008 E.II (B) dated 03.06.2024.
- 4. In the above context, keeping in view the above decision of the Central Government, it has decided to revise the rate of Dearness Relief permissible to those State Government pensioners/family pensioners, who are receiving pension in unrevised pay scale (Sixth Pay-Scale), as below:-

"Increase in Dearness Relief from 230% (Two Hundred and Thirty Percent) to 239% (Two Hundred and Thirty Nine Percent), w.e.f. 01.01.2024 may be sanctioned to those pensioners/family pensioners of the State Government, who are receiving pension in unrevised pay scale (Sixth Pay-Scale)".

 Sanction of the Council of Ministers on this proposal has been given in item no.25 of the meeting dated 20.09.2024, in continuation of Department of Finance, Document Memo No. 1909/Vi. dated 08.08.2024.
