The undersigned is directed to convey sanction of the Governor of Mizoram for enhancing Dearness Relief @ 4% from the existing rate of 36% to 40% to the pensioners and family pensioners under the Government of Mizoram with effect from 1.11.2024.

- The Enhanced Dearness Relief @4% shall be paid in cash to all pensioners/ family pensioners of Government of Mizoram who continue to draw pension/ family pension.
- Payment of Dearness Relief involving a fraction of rupees shall be rounded off to the next higher rupee.
- Payment of enhanced Dearness Relief should be made in Indian Rupee (INR).
