

It works under the control of Director General, RCB&KC New Delhi. The Centre currently caters the training needs of 15 Delhi based IA&AD offices.


RCB&KC is dedicated to enhancing the professional skills and job-related knowledge of personnel from its user offices. Our primary objective is to identify and address the specific training needs of the user offices as per their priorities in alignment with their annual work plan and specific jobs to be performed by target groups.

RCB&KC is committed to:

- Create a learning culture within the organization

RCB&KC conducts wide range of training programs such as General, EDP, MCTP Level 2 & 3, Refresher, OIOS, e-HRMS, Induction training for DRAAOs, and Orientation training for AAOs/Supervisors, etc. which are systematically scheduled in the Annual Training Calendar to ensure comprehensive coverage of training needs.

RCB&KC, New Delhi is designated as the Knowledge Centre for "Public Debt Management". Every year Centre organizes an All-India Training program on "Public Debt Management and Expenditure Management".

RCB&KC, New Delhi is situated at 5th Floor, A wing, Audit Bhawan premises and has been equipped with:-

Smart Classroom



of new initiative. As part RCB&KC New Delhi has converted one of its lecture halls (with a seating capacity of 30 persons) into a smart classroom. For this purpose, an Interactive Smart Board with OPS, an Auto Focus Video Conferencing Camera with AI features, and one All-in-one soundbar speaker system were procured and installed.

The smart classroom is being used to deliver lectures for the Centre's training programs since December 2023. The Interactive Smart Board encourages active participation and engagement among learners through multimedia the integration of elements such as videos, images, and audio clips into lessons. Smart boards promote collaboration by allowing multiple users to interact with the board simultaneously and with the help of 'On-screen' Annotation using the pen provided with the screen, the content can be explained more effectively.

Training Programs (Oct 2024 to March 2025)



During October 2024 to March 2025, RCB&KC New Delhi conducted 14 courses (2 General, 4 IT, 3 MCTP including Orientation training, 1 OIOS, 1 e-HRMS, 2 Refresher and 1 All-India Knowledge Centre topic) and trained 382 personnel.

The training sessions were handled by General and EDP core faculties/AAO(OIOS)/AAO(e-HRMS) of the RCB&KC, New Delhi, Head of the Departments and Group officers of IA&AD, serving/retired IA&AS officers, Group A & B Senior Officers of IA&AD, retired Senior Audit Officers and external eminent/expert faculties from reputed Training Institutes/Organizations.

program for Direct Six-week orientation training Recruited Assistant Audit Officers (DRAAOs). Promoted Departmentally AAOs (DPAAOs) Supervisors was organized between 27th January 2025 and 11th March 2025 (30 working days). 41 Assistant Audit Officers and O3 Supervisors from 14 user offices participated in this orientation training program. This training program focused on providing the trainees a comprehensive understanding of the organization and developing their administrative & technical knowledge. In this training, trainees participated in cultural activities, group activities, yoga & meditation and sport activities. Besides this, trainees made presentations on the topic given to them as part of their soft skill training on presentation skills. The trainees were also taken for field trip during the training.



Mid-Career Training Programs

During the second half of the 2024-25, two Mid-Career Training Programs (MCTP) Level-3 were conducted in which 60 trainees were imparted training.



Refresher Courses

On the direction of HQ office, two courses were identified by RCB&KC, New Delhi for organising 2-day refresher courses on (i) Interactive Data Extraction and Analysis (IDEA), and (ii) Certification and transaction audit of Autonomous bodies for the officers/officials already trained on these topics. In these two courses 41 participants were imparted training.


OIOS Course

One IAAD One System (OIOS) is a customized IT system for the entire IA&AD and aims to fully automate the entire audit process end-to-end viz. audit planning, execution, reporting and follow-up with real-time monitoring of the audit process, audit execution. especially implementation and assistance of OIOS. three AAOs (OIOS) as a Functional Helpdesk were posted in RCB&KC, New Delhi. 2-days training on the topic "QA/QC and Processing of Audit Products in OIOS" was conducted between 24th March 2025 and 25th March 2025 in which 21 Trainees were imparted training from different field offices.

e-HRMS Course

The implementation of HRMS 2.0 (Human Resource Management System) across IA&AD officers is a major step towards digitizing HR services. With the support of two AAOs(e-HRMS) as a Functional Helpdesk (FHDs), the system is streamlining processes like employee data management, leave and reimbursements. For this, two **FHDs** posted are RCB&KC, New Delhi. One 1/2 days (online) training on the topic "A walk through e-HRMS" was conducted on 31st January 2025 in which 25 trainees were imparted training from different field offices.

Management and Expenditure Management

RCB&KC New Delhi was designated as a Knowledge Centre for "Public Debt". As part of knowledge centre activity, RCB&KC New Delhi conducted an All-India Training on "Fundamental of Public Debt Management and Expenditure Management" from 17th March 2025 to 19th March 2025. 26 SAOs/AAOs and one Group Officer participated in this 03 days training program.

The objectives of this All-India training program were that the participants would be able to acquire knowledge on Public Debt and other borrowings of the Union and State Governments and their management by the Debt Manager, together with overview of public financial management, principles and processes of budget, fiscal rules, and reforms in policy formulations. RCB&KC New Delhi invited eminent retired IA&AS officers Shri Subhash Chandra Pandey, President of Institute of Public Auditors of India (IPAI) and Shri Govind Bhattacharjee, Professor of Practice in Arun Jaitley National Institute of Financial Management (AFNIFM), Faridabad as the resource persons.



Average Course Grading Over Last Two Academic Years






