


- 3. The Temporary Increase as 221% will be paid regularly along with monthly pension from June-2023, the difference of months from July-2022 & January-2023 to May-2023 of the proposed Temporary Increase will be paid in Three installments: (1) First installment along with the pension of June-2023 (paid in July-2023) (2) Second installment along with the pension of August-2023 (paid in September-2023 (3) Third installment along with the pension of October-2023 (paid in November-2023).
- 4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.
- 5. All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pension from their State Treasuries, Including Public Sector Banks.

January-2023 to May-2023 of the proposed Temporary Increase will be paid in Three installments: (1) First installment along with the pension of June-2023 (paid in July-2023) (2) Second installment along with the pension of August-2023 (paid in September-2023 (3) Third installment along with the pension of October-2023 (paid in November-2023).

- It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.
- All Accountant General of the respective Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pension from their State Treasuries, Including Public Sector Banks.
- Other Provisions governing grant of temporary Increase (Dearness Relief) to Pensioners such as regulations of dearness relief during employment/re-employment, regulations to temporary increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.
